


NOTE: The below numbers are all presented on a CALENDAR YEAR basis.

Total Membership down **10** people since 12/31/2022 but **+2** vs 12/31/2021.




Total Monthly Attendance in 2023 is **down** from 2022 and 2021.


Virtual Attendance is roughly equal to In-Person.
