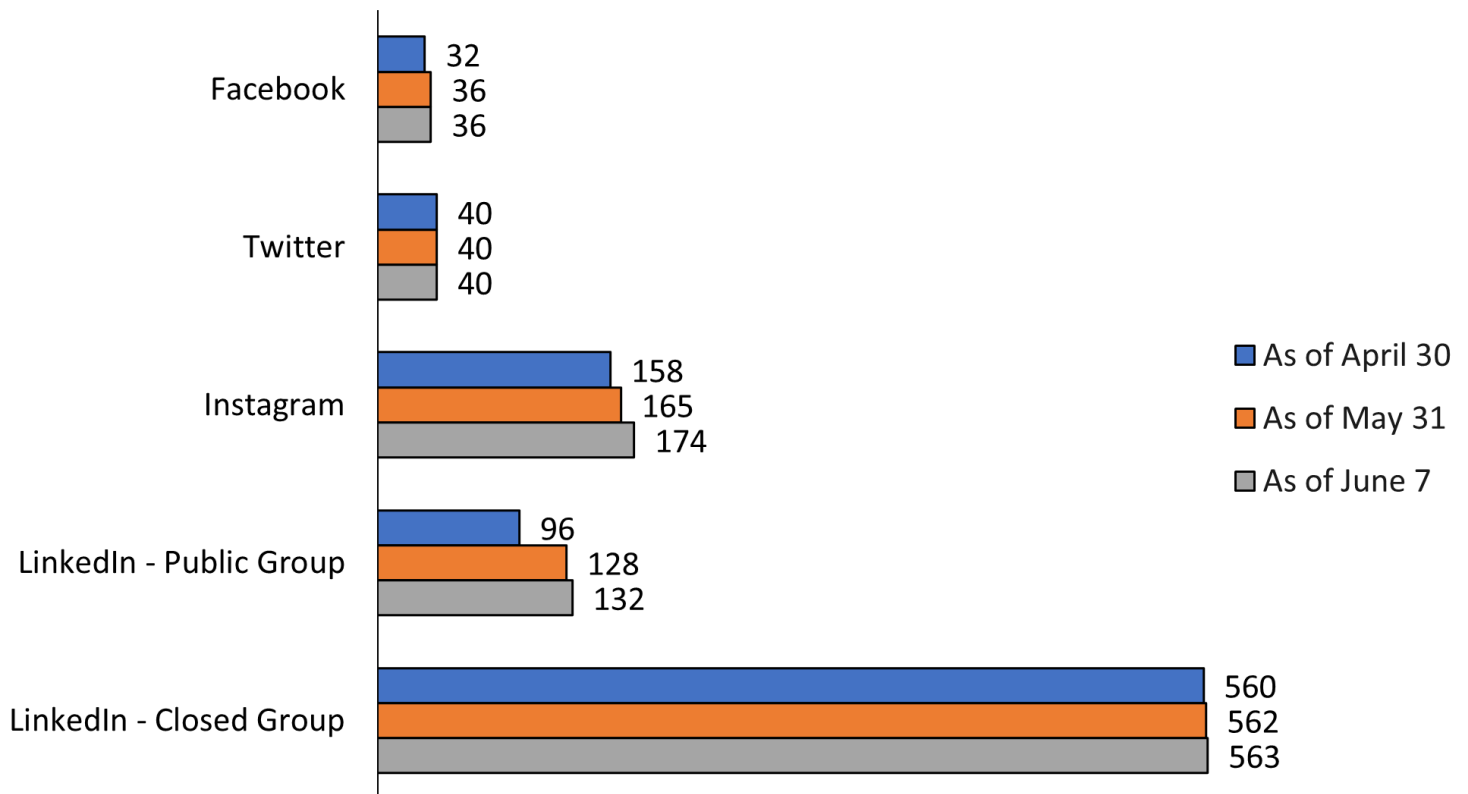

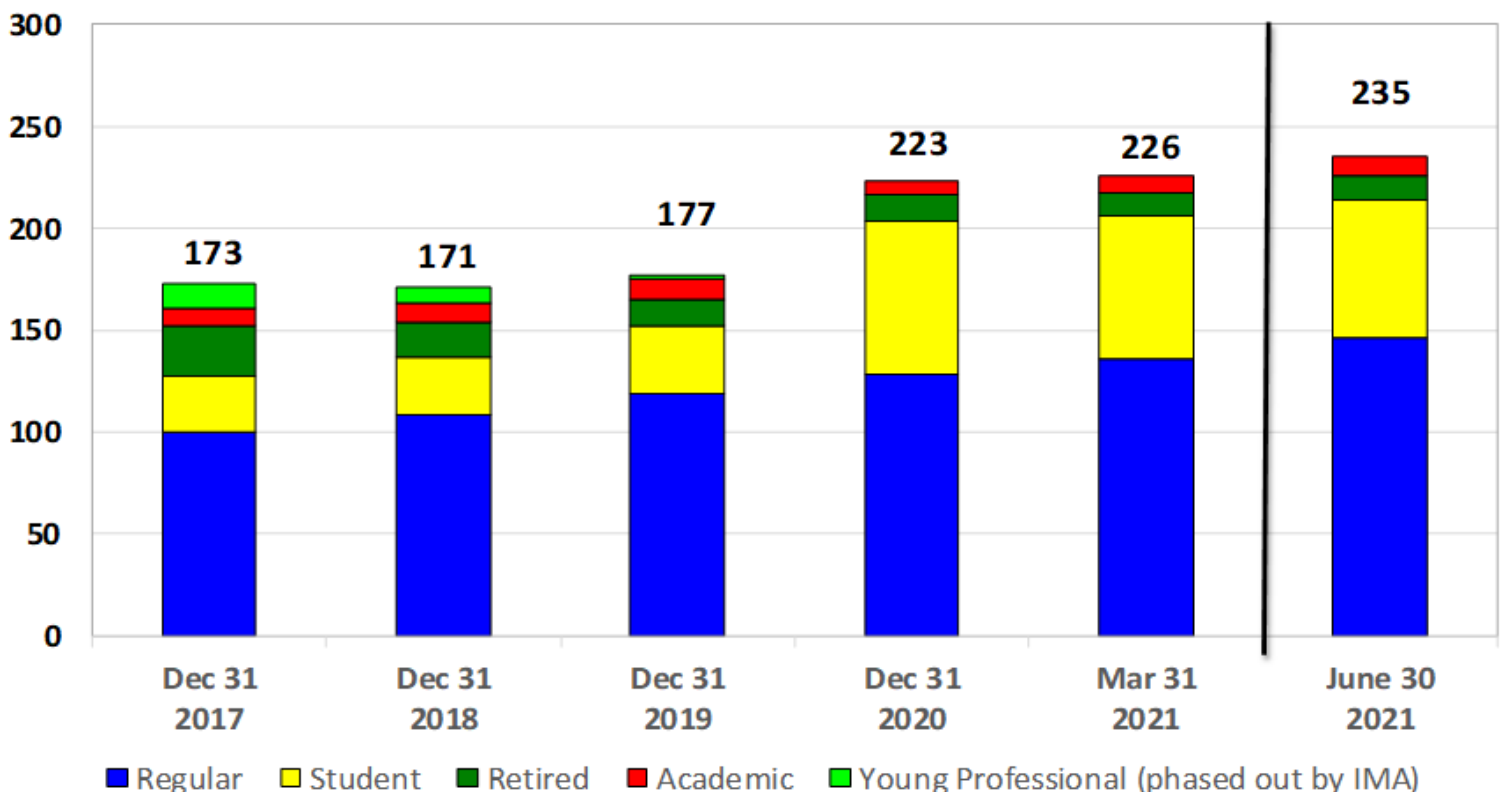

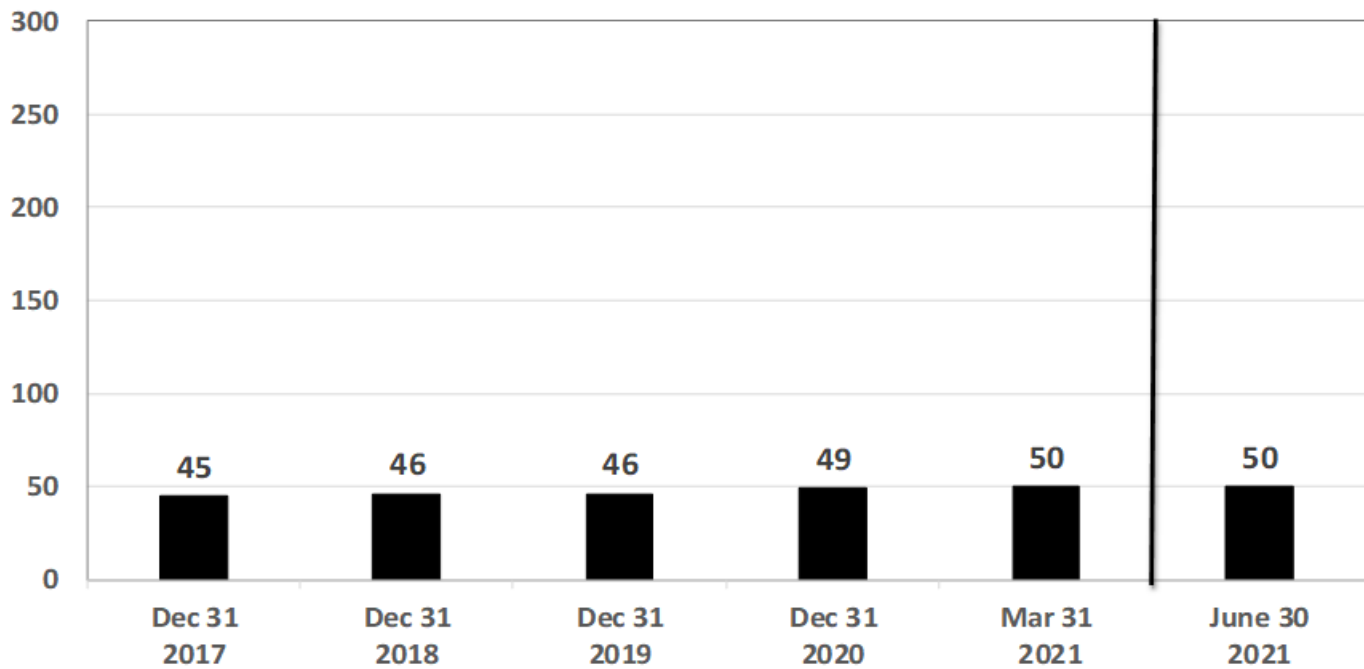
The one thing that's missing from all this is your colleagues. Invite them to come with you to an upcoming event and see the value for themselves. We'd love to have them join a winning team!

Your chapter is the most active chapter in Texas and certainly among the most active in the US. Way to go, San Antonio!

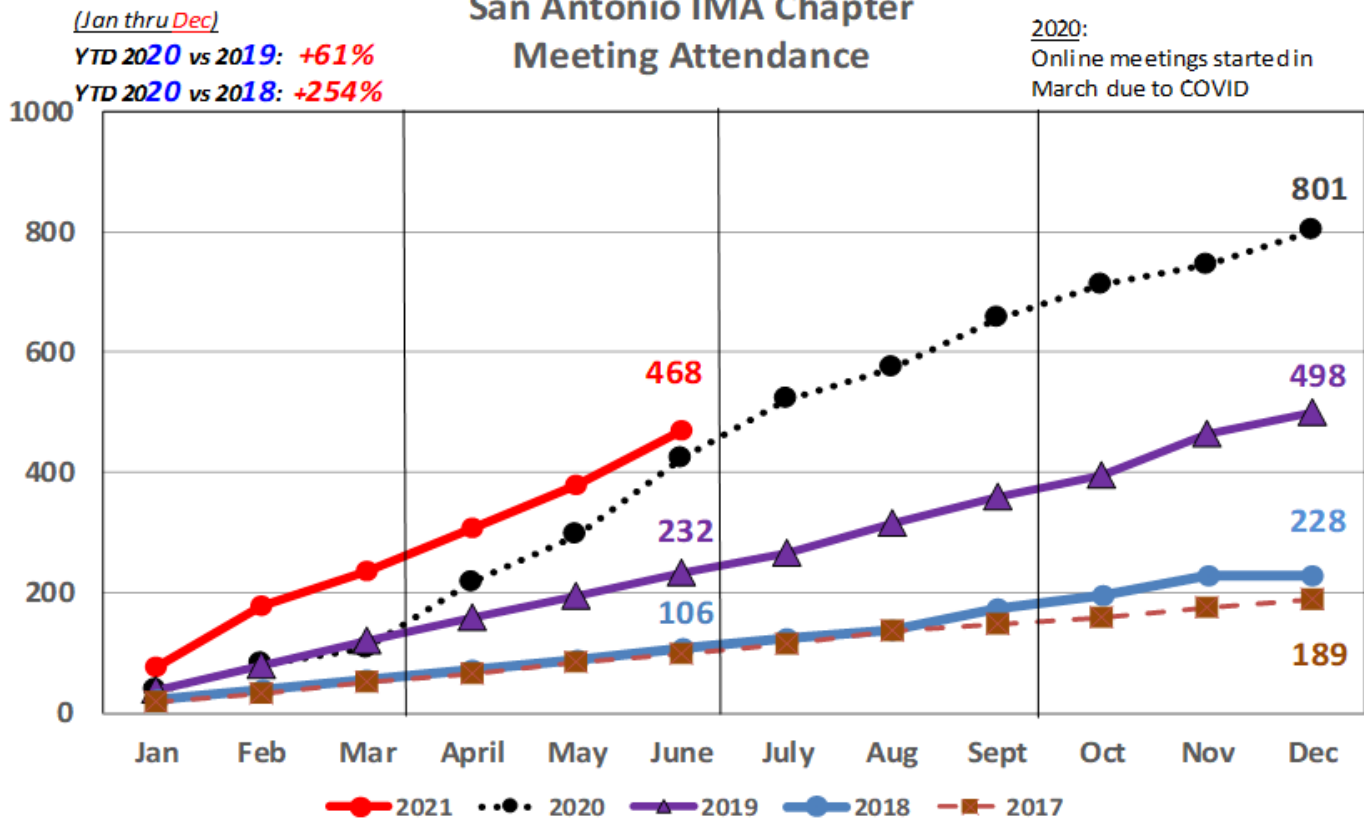

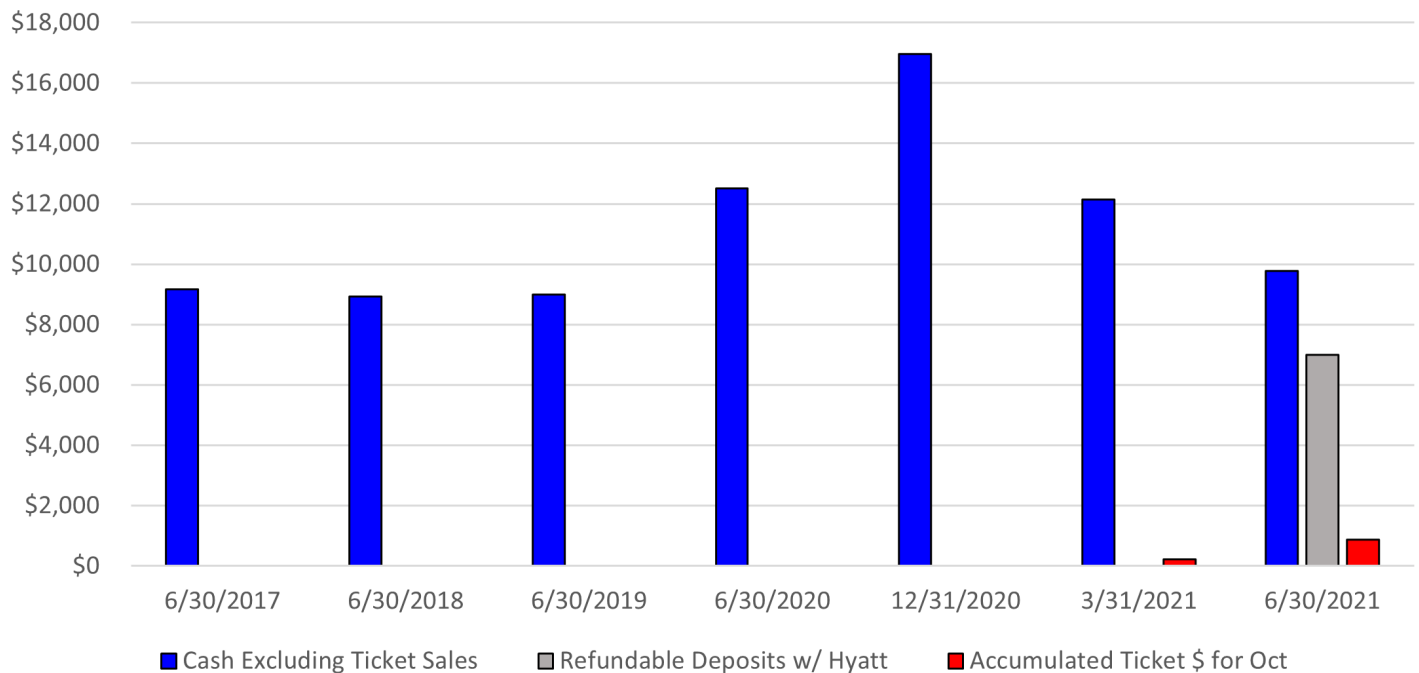

The Important Role of the CFO by Torey Reese, CMA, Treasurer

We often hear about the important role of the CFO. Typically, this importance is framed in terms of strategic and risk management. Yet a fundamental aspect of being strategic and managing risk lies in managing yourself and leading by example. "The average tenure of a [Fortune 1,000] CFO right now is less than three years," said Michele Heid, co-managing partner of the finance practice at Heidrick & Struggles. Meanwhile, CEO's average about 5 years per company.

Aaron Beam has experience as a CFO and can provide insight into why the turnover rate for CFO's is so high. Mr. Beam posits that CFO's traditionally coming from the accounting profession, tend to have an interest in pleasing people (with well-kept books) and being risk or conflict adverse. Which, from my experience, seems to hold water. While there is nothing wrong with this personality type it does not seem to lend well to the intense pressure of the C-suite. But don't despair! If you have your eyes on the CFO position, there are things you can do to improve your preparation for this role.

Aaron Beam is a diehard LSU fan, passionate about history and has been married to his loving wife, Phyllis for over 50 years. He went to school for a degree in economics, deciding the calculus required for chemistry would be too challenging. However, he found himself working in accounting and eventually worked with Richard Scrushy to begin and build HealthSouth, an innovative healthcare company that eventually grew to be the juggernaut of outpatient healthcare and the darling of stock analysts. They hit their 5-year strategic plan perfectly. However, to maintain extended growth, the financial department was encouraged to "pull the wagon" and "make the numbers." At that point, Mr. Beam became something else, a felon. While that pivotal time extended into a few years, the guilt ate away at him until he retired early to remove himself from the mentally/emotionally abusive relationship he had with his then boss, Richard Scrushy. His last year with HealthSouth was filled with drinking and other negative behaviors that caused him not to like himself anymore.

In his time since he testified about the fraud and served his sentence, Aaron has become a public speaker vehement in teaching accounting and other finance professionals about the pitfalls that led to his experience and how to avoid them. His focus on ethical study has led him to adopt a social contract theory model. Individuals choosing to act ethically, will build trust, in turn creating additional ethical actions. His work is now in public speaking and educating the current and future finance professionals so they do not repeat his mistakes.
