CMA Certified Professionals Earn 62 Percent More, According to IMA's Global Salary Survey

Montvale, N.J., March 1, 2018 – This year's Global Salary Survey from IMA® (Institute of Management Accountants) reveals that finance professionals with the CMA® (Certified Management Accountant) certification earn 62 percent more in median salary and 67 percent more in median total compensation than non-CMAs. That is an increase from last year's report, which found CMAs earned 45 percent more in median salary.

Buy-Sell Agreements: An Introduction

Buy-Sell agreements are common in family-owned and closelyheld businesses. When they are well-planned and well-drafted, they can provide a means to resolve disputes, transition ownership and facilitate retirement, among other matters. When they are poorly-planned or poorly-drafted, they can be a never-ending source of irritation, expense and inefficiency; and can even contribute to the break-up or failure of a business in extreme cases.

In this and the next few newsletters I will share some information about Buy-Sell agreements. Much of the information can be found in a text written by Z. Christopher Mercer titled, Buy-Sell Agreements for Closely Held and Family Business Owners. Chris Mercer has taken a leadership role in the valuation profession with Buy-Sell agreements, and his book is widely used by attorneys, accountants and valuation analysts. If you have a Buy-Sell agreement or if you are considering putting one in place, I recommend that you get his book.

His firm was contracted by Haldrup GmbH, a German manufacturer of heavy field research equipment. He led the startup team which built their North American operations and started Haldrup USA, Corp. In addition to his work in manufacturing, Phillip has done consultation for private equity firms. His work in this field involves mergers and acquisitions, business development, and portfolio optimization.

Phillip has always taken an active volunteer role in his community.
