





The innovations are in widely varied fields including engineering, medicine, agriculture, and economics, but all strike out in new directions ranging from Internet Service Providers floating 12 miles above in 50-foot wide balloons to a blood test that can detect cancers.

THE FUTURE IS NOW

Most of the breakthroughs are either available now or will be within the next couple of years. Only two—California Institute of Technology's work on nano-architecture and geneticists' attempts to supercharge photosynthesis—are listed as much further out (three to five years and 10 to 15 respectively). As the authors explain, some breakthroughs arrive fully formed, ready to package and distribute, while others just set the stage for innovations that will come later. "But," they confidently announce, "we'd bet that every one of the milestones on this list will be worth following in the coming years."

MAGIC LEAP'S 3D IMAGERY

The Magic Leap startup is working on a prototype that allows a viewer to see 3D rendered images projected into the actual space in front of and around them. Conventional 3D images involve two slightly separated images projected in front of you, at a distance, on a flat screen. They appear to be three-dimensional because each eye sees the image slightly apart from the other. Remember your View-Master? Combine that trick with the other illusion that creates motion in a motion picture (persistence of vision that blends one image into the next slightly separated image), and you have a 3D movie, most of which have been lame to lousy so far.



Recent stereoscopic 3D image systems have gotten better by bringing the dimensional images closer to you. The \$199 Gear VR rig lets you slide a smartphone into the headgear so that you can watch videos or play games.

And now, Magic Leap takes the final step into your head and in a way that doesn't interfere with what you're already seeing. "It has developed an itty-bitty projector that shines light into your eyes—light that blends in extremely well with the light you're receiving from the real world," writes Rachel Metz, who reviewed the system for *MIT Technology Review*. As she watched the clearly rendered images of models in the demo, she imagined uses for this technology. "I can envision someday having a video chat with faraway family members who look as if they're actually sitting in my living room while, on their end, I appear to be sitting in theirs...Or watching movies where the characters appear to be right in front of me, letting me follow them around as the plot unfolds."

One sign of a bright future for this technology can be seen in Google's substantial investment of \$542 million last October. The release date for the Magic Leap system hasn't been disclosed, but the founder and CEO Rony Abovitz told Metz, "It's not far away."

NANO-ARCHITECTURE

Julia Greer runs a lab at Caltech that specializes in materials. Last year, she created a ceramic substance that's not only one of the strongest materials known, it's also incredibly lightweight. In a video created by her team, a cube of the ceramic is crushed by a mechanical apparatus, but as it collapses and the weight is removed, it oddly lifts back up into its original shape. That's because the material is a nanolattice. It was made by a version of a 3D printer that uses laser light to very slowly create high-resolution polymer scaffolds at nanoscale levels that get coated with metals or ceramic.

So far, the materials produced exist in very small quantities. But it's the potential of these substances as building materials that support the research. One of the related teams Greer works with is made up biologists who want to see if her nanostructured ceramic "could serve as a scaffold for growing bones—such as the tiny ones in the ear whose degeneration is one cause of deafness."

CAR-TO-CAR COMMUNICATION

This is the next step up from the cars already on the road that use radar or ultrasound to detect obstacles or cars that are 20 or 30 feet away. Car-to-car communication is much more sophisticated. "It lets cars broadcast their position, speed, steering-wheel position, brake status, and other data to other vehicles within a few hundred meters." So your car would have a clear picture of everything around it with enough space to allow time for reacting to situations.

To work, this system requires that you wirelessly network cars together instead of just installing radar. Prototypes at the General Motors research center in Warren, Mich., are rigged with computers that broadcast the information 10 times a second over 802.11p Wi-Fi. The motivation for the research is the more than 30,000 killed annually in car crashes. Car-to-car networking is also being tested in Europe and Japan.



GOOGLE'S LOON BALLOONS

While here in the United States the FCC is working on legally defining the Internet as a public utility service, protected by the fair practices you would expect for gas, electric, and your phone, Google is trying to come up with the best way to provide service to the 4.3 billion, planet-wide, who still live offline. Right now, the company has a couple dozen helium balloons floating over the Southern Hemisphere at twice the altitude of commercial airlines. They are about 50-feet across, and each supports a 33-pound gondola with solar-powered computer equipment that's beaming down high-speed cellular Internet access. Google calls them Loon Balloons. Software in the gondola expands and releases pressure within a balloon in the balloon, and that causes the Loon to raise or lower in the stratosphere to keep it in the airstreams that guide it. The trick is to keep enough Loons in an area to provide coverage. That means having at least one of these sailing ISPs within 40 kilometers of the telecommunications network on the ground at all times.

The project is three years old, and Google's ground control has logged more than three million kilometers (1.9 million miles). Mike Cassidy, the leader of Google's Project Loon, hopes to have a sufficient number of balloons aloft by the end of this year to get the service up and running in several areas in the Southern Hemisphere. The service will be offered to cellular providers who could expand their own networks into areas presently not covered by anyone.



LIQUID BIOPSY

Dennis Lo, a doctor in Hong Kong, China, has spent the last 20 years working on a unique method for detecting cancer. He calls the process a liquid biopsy, and it consists of drawing a small sample of blood and then sequencing the DNA in the sample. Lo first achieved public notice in 1997 when he developed a DNA screening for blood taken from expectant mothers that would identify Down Syndrome. The cancer screening test he is currently developing works on the same principle that enables the prenatal test. Dying cancer cells deposit DNA into the blood of the patient, and although they are very difficult to detect in the beginning, the DNA becomes more identifiable as the disease progresses.

Lo is currently managing a study of 20,000 healthy males who are routinely tested for signs of cancer in their blood. Gene-sequencing machines are used to decode fragments of DNA that are present in the blood. Although the process and the machines are too expensive for widespread use, as the testing becomes more reliable and the machines become more efficient and cheaper, that might change. Eric Topol, who teaches genomics at the Scripps Research Institute predicted earlier this year "that the technology, applied to cancer and other diseases, will become the 'stethoscope for the next 200 years."

MEGASCALE DESALINATION



Citing the matrilineal relationship between necessity and innovation, David Talbot writes about the advances at the world's largest, and currently cheapest, seawater desalination plant in Tel Aviv, Israel. The necessity side of the equation involves 700 million people today who don't have sufficient sources of clean water and the 1.8 billion in the next 10 years. The invention addressing the need is reverse-osmosis desalination that renders seawater drinkable.

Talbot explains that 10 years ago in Israel, the sources of clean water were rainfall and groundwater. Today 40% of the country's water is from four desalination plants, and that will increase to 50% by 2016. Technological improvements at the new Sorek desal plant in Israel include larger pressure tubes, more efficient pumps, and energy recovery devices providing "the cheapest water from seawater desalination produced in the world," according to Raphael Semiat, a chemical engineer at the Israel Institute of Technology in Haifa. Continuing research on the filter membranes is moving toward sheets of carbon with the thickness of one atom that are capable of cutting the energy costs of operation.

APPLE PAY

Number six on the *MIT Technology Review* list is the recently released Apple Pay system for iPhones. What makes Apple Pay better than the Google Wallet system released back in September 2011? With both you pay with your smartphone, and both help eliminate credit-card fraud. So why would the Apple system succeed where Google's never really caught on? Well, according to Robert Hof, who wrote the piece on this breakthrough for the MIT article, it's just that Apple has made the process so much simpler than others who have tried this before. You sign up for the service, use your phone's camera to take a picture of your credit card, and Apple approves the card with your bank. As to security, it's wired in and mostly invisible.

With a credit card, the store or service reads your card and approves the sale. But they also often keep a record of your card, and sometimes they (Target, Neiman Marcus, Home Depot, etc.) get hacked and your number gets vacuumed up by some individual or syndicate somewhere in the world. When Apple Pay approves your card, the photo is deleted from your camera automatically, and the record gets encrypted. The stores you visit never collect your card number because the clerk and store never see your number. With the swipe, Apple creates an encrypted device account number that is used to identify you—your credit card number is not on your phone. And finally, there's the built-in biometric firewall of Touch ID. Only your fingerprint will enable the transaction from your side of the counter.

BRAIN ORGANOIDS

Madeline Lancaster and Jürgen Knoblich of the Institute of Molecular Biotechnology in Vienna, Austria, have replaced lab animals in their research on the brain. Instead of mice or monkeys, the team has perfected "brains growing in a dish," known more properly as cerebral organoids. These are tissues that have some of the characteristics of the human brain as it appears in the first trimester of development. These clusters of neurons sufficiently recreate brain functioning to serve as subjects for studying brain disorders and diseases. The organoid starts as a skin cell from an adult human. "With the right biochemical prodding, that cell can be turned into an induced pluripotent stem cell (the kind that can mature into one of several types of cells) and then into a neuron," Russ Juskalian reports. The resulting neurons can provide information about the growth and functioning of the human brain. But more importantly, because the organoid is derived from a specific person, tissue clusters grown from a skin cell of someone suffering from schizophrenia or Alzheimer's disease can be analyzed for clues about those dysfunctions.

SUPERCHARGED PHOTOSYNTHESIS

Not all plants leverage the process of photosynthesis with the same efficiency. When it comes to converting sunlight into chemical energy that causes the plant to grow, a plant like corn is much more efficient than rice in firing up the process that keeps the planet green and people fed. In his description of breakthrough number 9, Kevin Bullis writes about something called C4 photosynthesis—a supercharged process that works by capturing and shunting carbon dioxide, "concentrating it in specialized cells in the leaves. That allows the photosynthetic process to operate much more efficiently." And the difference C4 can make could be significant. Bullis continues, "If C4 rice ever comes about, it will tower over conventional rice within a few weeks of planting." The yield per hectare would be increased by 50%, and there would be far less water and fertilizer required.



In December, geneticist Paul Quick at the International Rice Research Institute in the Philippines and Julian Hibberd at the University of Cambridge in the U.K. successfully introduced C4 photosynthesis genes for the first time into a rice plant and duplicated the increased carbon dioxide capture seen in plants that have supercharged photosynthesis. Why rice, and why is that so important? Bullis points out that 40% of the diet of humans consists of corn and rice, and recent statistics show the leveling off of the yields of these crops at a time when populations continue to grow.

Progress is slow, and it's likely to take a decade or more before the genetic modifications will appear in rice fields, but according to Bullis there are also a number of other crops that are part of the C4 research, including wheat, potatoes, tomatoes, apples, and soybeans.

INTERNET OF DNA

The final breakthrough in MIT's list involves the crossing of paths of genomics and big data. As labs are now able to sequence human genomes at the rate of two per hour and medicine is increasingly turning to sequencing for diagnosis and treatment, the need for large, available databases for researchers and practitioners is growing. In his article for the MIT Technology Review, Antonio Regalado illustrates the value of such a database with the case of a six-year-old who is suffering from an unknown disorder that has seriously delayed his development, is shrinking his cerebellum, and is making him sicker with symptoms that have stumped his physicians. His DNA was analyzed but it revealed no clues. "Somewhere in the millions of As, Gs, Cs, and Ts is a misspelling, "Regalado writes, "and maybe the clue to a treatment. But unless they find a second child with same symptoms, and a similar DNA error, his doctors can't zero in on which mistake in Noah's genes is the crucial one." They plan to send Noah's DNA information out on the Internet, but today there are no protocols for collecting, organizing, and sharing DNA databases. Regalado explains that this will have to change. He quotes Arthur Toga, a researcher who leads a consortium studying the science of Alzheimer's: "There's going to be an enormous change in how science is done, and it's only because the signal-to-noise ratio necessitates it. You can't get your result with just 10,000 patients—you're going to need more. Scientists will share now because they have to." The leaders calling for the aggregation of an Internet-wide database of genetic information include the Global Alliance for Genomics and Health, the Personal Genome Project, and Google.
