

The AOCS FOUNDATION respects the privacy of its members and other visitors to its Web site. Whenever we change our privacy policy, we will give reasonable notice by posting a notice on our home page. Since these policy change notices last only for a limited time, however, you should check this Privacy Policy regularly to see if there have been any changes. To protect online privacy, The AOCS FOUNDATION has implemented the following policy.

What Information Does THE AOCS FOUNDATION Collect?

Most data THE AOCS FOUNDATION collects is used only to help us better serve our members and visitors and improve their web site experience. It is our general policy to collect and store only personal information that our members and visitors knowingly provide.

From All Users. THE AOCS FOUNDATION does not collect any personal information from users browsing its Web site. Only aggregate data -- such as the number of hits per page -- are collected. THE AOCS FOUNDATION uses the ClickTale web analytics service. ClickTale may record mouse clicks, mouse movements, scrolling activity as well as text you type in this website. THE AOCS FOUNDATION does not use ClickTale to collect any personally identifiable information entered in its website. ClickTale does not track your browsing habits across web sites which do not use ClickTale services. Aggregate data and data collected from the ClickTale service is only used by THE AOCS FOUNDATION for internal and usability purposes and do not provide any personally identifying information.

How Does THE AOCS FOUNDATION Use Data Collected?

The AOCS FOUNDATION uses information voluntarily submitted by members and other customers in the following ways:

THE AOCS FOUNDATION Member Services and Products. Generally, The AOCS FOUNDATION uses data collected to improve its own web content; to respond to visitors' interests, needs and preferences; and to develop new products and services.

Disclosures to Third Parties. THE AOCS FOUNDATION also makes member contact information available through the AOCS FOUNDATION Membership Directory to other members using its Web site. In addition, THE AOCS FOUNDATION incorporates information members provide into hard copies of the Membership Directory that it provides to members upon payment. THE AOCS FOUNDATION also shares limited contact information to those who register for the AOCS FOUNDATION meetings and conferences. On occasion, THE AOCS FOUNDATION may also provide limited data to third parties that offer products and services. These limited data include names, job titles, companies and business addresses, but do not include business phone numbers, business fax numbers or email addresses. Users may request the AOCS FOUNDATION to refrain from disclosing the data it collects to third parties by contacting the AOCS FOUNDATION at membership@aocs.org or 217-693-4818 to express their preferences if they determine later that they do not wish to have the information shared.

At all times, however, THE AOCS FOUNDATION reserves the right to disclose information where required by law or to comply with valid legal process to protect THE AOCS FOUNDATION' rights or property, including without limitation in the event of a transfer of control of THE AOCS FOUNDATION or substantially all of its assets, or during emergencies when safety is at risk.

Consent to Use Personal Information. For the purposes of the Data Protection Act(s) 1984 and 1998 (as applicable), THE AOCS FOUNDATION or its agents must store, host and otherwise process the information (including personal data) supplied by the User when registering for this Web site.

Credit Card Account Information. THE AOCS FOUNDATION does not disclose credit card account information provided by its members and customers. When members and customers choose to pay using their credit cards, THE AOCS FOUNDATION submits the information needed to obtain payment to the appropriate clearinghouse.

Children's Privacy. THE AOCS FOUNDATION's website is intended for adults. THE AOCS FOUNDATION does not knowingly collect personal information from children under the age of 13. If THE AOCS FOUNDATION obtains knowledge that it has personally identifiable information about a child fewer than 13 in retrievable form in its files, THE AOCS FOUNDATION will delete that information from our existing files.

How Does THE AOCS FOUNDATION Use Cookies?

Cookies, if they are used at all, are small text files created by a web server during the course of visiting a website, and placed on the hard drive of the website visitor (User).

A cookie can remain in existence during a particular browsing session (a "per-session" cookie), and is deleted, or "expires" when the browser is closed, or it can be stored for future use (a "persistent" cookie). Persistent cookies can be configured to last a determined amount of time before expiring.

The AOCS FOUNDATION website uses both types of cookies, but only to facilitate automated activity, store and track passwords, determine appropriate solicitations and solutions, and to enhance and ease the User's experience.

THE AOCS FOUNDATION cookies are not used to disseminate or share or otherwise make available significant information about Users over the Internet, or to analyze information that Users have knowingly or unknowingly provided. Information in THE AOCS FOUNDATION cookies is never shared with any third party outside of THE AOCS FOUNDATION.

THE AOCS FOUNDATION cookies are typically created and used for login procedures, registration and other web forms. They may also be used to keep anonymous track of user movement throughout the AOCS FOUNDATION website. This information may be used by THE AOCS FOUNDATION staff to detect and resolve website problems and to assist with EMAIL User support.

THE AOCS FOUNDATION does not use cookies to collect any personally-identifiable information about site Users.

Users may configure their browsers to opt out of accepting cookies completely, or configure their browsers to accept only certain types of cookies, for example, accepting "per-session" cookies but not accepting "persistent" cookies. Users may also configure their browsers so that the User is notified of and can accept or reject any given cookie, or Users can turn off this notification feature completely.

However, restricting acceptance of the AOCS FOUNDATION cookies will mean the User may not have access to all features and benefits of the AOCS FOUNDATION website.
