Call for Submissions SPPSN Best Paper award

The INFORMS Section on Public Programs, Services and Needs is sponsoring an award for best paper presented at the INFORMS fall national conference in Phoenix, October 14 – 17, 2012. This award is intended to encourage journal-quality research in all of the disciplines and application areas represented within SPPSN, and to build a tradition of scholarly exchange of knowledge at our research meetings beyond attendance at sessions. Participation is open to all INFORMS members, whether students, academics or practitioners. Each submission must be associated with a presentation at the fall national conference. Subject to receiving qualified submissions, one first prize of \$250, one second prize of \$100 and an honorable mention will be awarded at the SPPSN business meeting, to take place at the INFORMS fall 2012 conference.

The submission process consists of the following:

- A nomination letter, not to exceed two pages, explaining the relevance of the paper to SPPSN's mission and the paper's significance to research and/or practice, as well as a paper abstract (not to exceed 250 words), are due by July 6, 2012.
- Eligible participants will be invited by July 20, 2012 to submit a full paper to the judging committee.

- Final drafts of papers are due on September 7, 2012.

Submission requirements are:

- Papers must be a maximum of 32 pages long, including title, abstract, all text, references, figures and tables.
- Papers must be formatted to one-inch margins on all sides, a font size of at least 10 point, and at least 1.5 line spacing.
- The paper under consideration for this prize shall not have not been published elsewhere.

Journals and Books

Special Issue of *Annals of Operations Research*

The Annals of Operations Research seeks submissions for a special volume on Policy Analytics. The deadline for submission is 31 October 2012. The full announcement is at http://rutcor.rutgers.edu/POLICY_ANALYTICS.pdf.

The background to the special issue is as follows. The last few decades have seen rapid growth in the capacity of businesses to exploit IT, OR and statistical modelling to collect and process operational and market data in order to support decisions. As a result, business analytics has become a flourishing field for consulting and business education. In contrast, while government decisions are often supported by traditional policy analysis, few government departments and agencies have yet managed to make the systematic use of data, evidence, OR methods and cutting-edge modeling. In this call, we therefore invite papers which apply the methods and ideas of "analytics" to problems arising in the operational management of public services and in policy making.

Submissions could concern policy making or delivery in areas such as healthcare, social or municipal services, national security and border protection, the provision of welfare benefits, the collection of taxation, the protection of the environment or the allocation of natural resources, the administration of the civil or criminal justice system, educational provision, economic regulation, industrial and cultural policy, or any of the other tasks which governments undertake.

This special issue seeks papers presenting both conceptual advances and innovative applications, recognising that public sector applications must balance the need for robust and convincing analysis with legitimate public expectations about transparency and opportunities for participation. Papers may deal with contributions

through different phases of the policy cycle: from issue identification; policy testing and analysis; to policy implementation and evaluation.

Contributions from Decision Theory, Social Choice Theory, Measurement Theory, Welfare Economics, Policy Analysis and related fields are encouraged. Papers which show how recent IT innovations (in social networks, distributed and/or cloud computing, machine learning, knowledge extraction, artificial intelligence, data mining) and operational research methods (problem structuring, multi-criteria decision analysis, optimization techniques, evaluation models) have shaped the broad area of policy analytics are also particularly welcome.

I am writing to invite your submissions to Socio-Economic Planning Sciences, which focuses on the development and use of quantitative methods for tackling decision problems in the public sector. We use the term "public sector" with its widest possible interpretation that includes the sectors where public and private institutions co-exist e.g., healthcare, energy, transportation. All published articles, however, need to establish the relevance of the contribution in the public domain.

The first two issues of this year (Vol. 46) are devoted to disaster planning and public sector facility location, respectively. There are also two more special issues currently being prepared that focus on energy modelling and healthcare modelling. Recently published papers also include works on the environment, education and judiciary sectors as well as performance measurement challenges at the regional and national levels. New Book

Transforming U.S. Army Supply Chains: Strategies for Management Innovation. Greg H. Parlier, Business Expert Press, New York, 2011, 290 pages.

This text offers a practical approach for understanding the US Army's extremely complex global logistics system, widely acknowledged as one of the largest in the world. The focus is on inventory management policy where prescriptions are illuminated through the prism of an enterprise supply chain analysis. Although Army aviation logistics examples are emphasized throughout, the fundamental issues and potential solutions are broadly applicable to other large-scale military and industrial supply chains as well. Following a summary of recent trends for background and context, a multi-stage conceptual model of the logistics structure is presented to segment and guide the effort. This multi-stage model is used to systematically analyze major organizational components of the supply chain, diagnose structural disorders and prescribe solutions. Integration challenges are addressed using cost-benefit perspectives which incorporate supply chain objectives of efficiency, resilience, and effectiveness. The design and evaluation section proposes an "analytical architecture" consisting of four complementary modeling approaches, collectively referred to as "dynamic strategic logistics planning", to enable a coordinated, enterprise approach for Army Logistics

Transformation. An organizational construct is presented for an “engine for innovation” to accelerate and sustain continual improvement for Army logistics and supply chain management – a “Center for Innovation in Logistics Systems”. Finally, strategic management challenges associated with enterprise integration and transformational change are addressed: organizational design; management information and decision support systems; strategic alignment for a learning organization; and workforce considerations including human capital investment needs. The text concludes with a relevant historical vignette and closes with a summary of expected benefits.

The book demonstrates an application of “management innovation as a strategic technology.” MIST, for short, is a new concept for transformational change in large-scale, complex, interdependent organizations that compose an extended enterprise. The three conceptual building blocks for MIST include (a) data-driven, operations research-based, decision support systems (also referred to as “business intelligence” or “analytics”); (b) a transformational, rather than incremental, approach to strategic planning that is guided by an “engine for innovation”; and (c) an “integrated” management science to increase the likelihood for successful transformative change by enabling, rather than impeding, organizational implementation. By describing the components of MIST and demonstrating their application to army materiel enterprise challenges, others will hopefully be encouraged to consider and, where appropriate, adapt and apply MIST to our many other daunting national security challenges. ***A fourth purpose of the book, then, is to develop an appreciation and understanding of MIST and its emphasis on analytical architectures as a strategic management means for improved performance in our public sector organizations and government institutions.***

About the INFORMS Section on Public Programs, Services and Needs

The Section for Public Programs, Service, and Needs (SPPSN) is the INFORMS subdivision dedicated to, in the words of the INFORMS slogan, “doing good with good OR.” The section furthers the use of operations research and management science in the following areas:

- *Public Policy* – improving governmental decision-making at the legislative and strategic levels.
- *Public Programs* – improving the management of government programs, services and operations.
- *Public Safety* – improving decision-making in support of homeland security, law enforcement, emergency preparedness, and disaster response.
- *Public Service* – supporting community development and public service organizations, and encouraging members of the ORMS professions to volunteer their know-how in public service causes.

- *Public Needs* – Improving logistics and other national and international programs to address humanitarian needs.

The section carries out its mission by sponsoring presentations at INFORMS national meetings and providing publicity for ORMS conducted in the public and civic spheres.

SPPSN was formed from a 2009 merger of three efforts devoted to “doing good with good OR”. The first was the Public Programs and Processes Section (PPPS), which was the INFORMS section devoted to OR conducted in the areas of public policy, public programs and public safety. The second was an initiative to start an INFORMS forum devoted to community operations research and the third was an initiative to start an INFORMS forum devoted to supporting humanitarian assistance. The three groups, in consultation with the INFORMS Subdivision Council, decided that the best approach was to have a single expanded section that would broadly

address ORMS conducted in the public and civic spheres.

Membership is \$8 for INFORMS members, \$10 for non-members, and \$5 for students.
