Winter Conference: Projects and Organizations

February 5-8, 2015 Park City, Utah

We are pleased to announce the twenty-first annual Organization Science Winter Conference (OSWCXXI). This year's winter conference will be devoted to the topic of projects and organizations. The meeting will take place February 5-8, 2015, at the Canyons Grand Summit Hotel, Canyons Resort, Park City, Utah.

Call for Papers

A core feature of organizations is to coordinate interdependent behavior. However, coordination is not directed merely at reoccurring action patterns but at achieving novel outcomes. Projects are a critical fulcrum of coordinated action and novelty. Despite their centrality in organizational life, "projects" as a construct are under-theorized as a unit and level of analysis. Projects are characterized by their temporary nature, by horizontal rather than vertical (command and control) relationships, by unclear accountability, by shifting commitments and by unclear expertise. This conference is designed to place the project in the foreground of theorizing in order to find where existing organizational theories break down and to provoke new theorizing about organizations. Some examples of potential topics include the following:

- Project-based organizations: The increase in numbers of project-based organizations can be seen as a response to
 dynamic markets in which command and control approaches are no longer appropriate. To what extent do existing
 macro, meso, and micro theories of organizations apply in the context of project-based organizations? Where and under
 what conditions are project-based organizations applicable? What are the potential advantages or disadvantages of this
 form of organizing for individual, group and organizational outcomes?
- Projects and teams: In the vast literature on teams and team dynamics, scholars have paid less attention to the fact that
 teams tend to work on projects. Often the project is the driving force in assembling and changing a team over time. As
 projects shift, teams' structures and dynamics may also shift. What can be gained from shifting the focus from teams to
 projects? Reciprocally, what can theories of teams contribute to the development of theories about projects?
- Projects and knowledge: Projects because they are temporary and often comprised of distributed members pose
 particular problems for knowledge within and across organizations. Little research has examined how knowledge is
 coordinated in these organizational forms. How can knowledge be transferred, coordinated and used in distributed
 projects and across (temporary) projects over time?
- Projects and routines: A well-established literature has shown how routines can be sources of stability and change in
 organizations. However, an emerging stream of work suggests that routines are not enough for understanding how new
 actions emerge in organizations and proposes projects as a complementary form of organizing. How can attention to
 projects help us understand organizational change? What theories can connect project work to routine action?
- Projects and strategy: Strategy research has typically been done at the firm- or individual-level and unit of analysis. However, strategy is typically formulated and often executed in the form of projects or strategic initiatives. What can be gained by using projects as a unit of analysis in strategy? What contrasts can we draw with findings that focus on firms as monolithic wholes?
- Projects and institutions: Institutional theory has been grappling with theories of change in institutions. Existing
 explanations have focused on institutional work and institutional entrepreneurship. Little theory has been developed
 about the role of specific projects/campaigns/strategic initiatives in shaping change. Could this be a useful lens for
 understanding how fields are built, maintained and changed?

We invite 2- to 3-page proposals for plenary panels and individual paper contributions that might link in interesting ways to the various themes related to projects and organizations. As has been the case in the past, some contributions will be presented as part of the plenary program, while others will be invited to join another highly acclaimed OSWC tradition—the open-ended evening-long (7–10 p.m.) Interactive Poster Sessions accompanied with finger food, wine, soft drinks, and desserts. Furthermore, if you are interested in attending OSWCXXI but not as participant on the program, please submit a statement expressing your desire to participate and describing your interest in topics addressed above.
