Minutes of the 2023 MSOM Business Meeting at MSOM 2023


Time: 7:00m-8:30pm EDT Sunday, June 25th, 2023

Location: Montreal, Canada

- 1. President Burak Kazaz welcomed the participants and started the meeting by introducing the agenda and the set-up for the meeting.
- 2. Secretary/Treasurer Esma Gel was not able to attend the meeting, so President Burak Kazaz gave an update on finances and membership numbers.
 - a. We had a beginning balance (on 1/31/2022) of \$171,668 and ending balance (12/31/2022) of \$174,058. As of 3/31/2023, the Society has a cash balance of \$178,790.
 - b. Dues revenues increased slightly from \$20,454 in 2021 to \$22,321 in 2022, showing a slow recovery in memberships since the pandemic.
 - c. The following picture shows the membership levels over the past five years. We currently have 1400 total members, about 450 members lower than the high point that we achieved in 2018, right before the pandemic.



d. The above picture also shows slow recovery from the pre-pandemic periods, but looking at the other societies, we see similar trends in lagging membership numbers, suggesting that efforts to stimulate membership are worthwhile.



- e. Student members are about 26% of the membership, which is a steep decrease from the max of 39% we had; efforts to increase student membership can ensure the long-term health of the MSOM membership.
- f. In 2023, the Board members sent an email to previous members (student and regular) to increase membership numbers. We are not sure how well this approach worked (since it is still too early to check membership numbers) but we believe that similar activities are worthwhile to pursue in the upcoming years to ensure healthy membership numbers.

- 7. VP of Meetings Aydin Alptekinoglu shared some reflections on the future of MSOM summer conferences.
 - a. Our annual conference is over-subscribed: The demand for speaking time far exceeds the supply. A case in point: The overall acceptance rate was 59% in MSOM 2023 (further details given in slide 41 of the business meeting slide deck).
 - b. To take steps toward mitigating this supply-demand imbalance, the current year's Board is recommending the deployment of a survey to gather the MSOM Society's input on how the conference should evolve. We will be drafting a survey to elicit our community's preferences and suggestions regarding the conference. The basic decision appears to be between being selective (or, becoming even more so) with commensurate improvements on the conference's review process and being inclusive with commensurate increases in conference's speaking-time capacity (e.g., by shorter talks, additional tracks, or an extra conference day).
- 8. President Burak Kazaz provided an update on the new initiatives.
 - a. SIG Conference and Fast Track Papers
 - i. The initiative will help raise the quality standards of the referee reports for the SIG conference
 - ii. Each SIG is represented by three scholars: SIG Chair, SIG day event co-chair 1 (selected by SIG chair) and SIG fay event co-chair 2 (An AE from M&SOM, selected by DEs and EiC)
 - iii. Details of the process that has been implemented can be found on the slide deck. The following statistics on this year's conference submissions has been presented. About 5 papers out of 290 were passed on to the journal for fast tracking.

iv. Other than a few lessons learned, we find the Fast Track process to be satisfactory to achieve the goals that we had initially set. These lessons are documented and will be transferred to the next Board and SIG groups.

- b. Africa initiative: The goal of the Africa Initiative is to stimulate collaborative research that would enrich the OM professional community in research and teaching, as well as in diversity and inclusivity: (i) to serve the interests of the African economy and people through research in collaboration with colleagues in Africa; (ii) to help the profession with new ideas, new solutions, and new approaches in research for mainstream OM.
 - i. This year we have one session in this conference featuring Africa-related research by researchers from the region.
 - ii. We hope to increase the participation from African universities in the future.

 - iii. Overall acceptance rate is at 13% for regular and 7.3% for fast track.
 - iv. Average time to first decision was 71 for regular papers and 31 for fast tracked papers. Median to first decision was 90 days and to final decision was 104 days.
 - v. 625 OM related papers submitted in 2022. Acceptance rate was 19.3% for regular papers and 8.7% for fast tracked papers.
