- Policy: A single prize will be awarded each year by the MSOM Society of INFORMS to a young researcher who has made a significant contribution to scholarship in operations management.
- Purpose: To recognize outstanding contributions to knowledge in operations management made by a young scholar.
- Eligibility: Anyone of age 40 years or younger on January 31st of the year in which they are nominated.
- Cash Prize: \$1,000

- 11. President Serguei Netessine announced a new policy at Management Science limiting the number of revision rounds to two, after which only the DE and the AE would handle the paper.
- 12. Editor-in-Chief Elect of M&SOM Chris Tang provided an update on the journal
 - Past and Present:
 - 400 submissions per year
 - o Process: 1 editor and 73 AEs. Cycle time is less than 75 days in 94% of the cases
 - o 500 published articles between 1999 and 2014
 - o Contributors: 700+ authors
 - o Impact factor: 1.43 (2013); 5-year impact factor: 2.69
 - Future (2015-17):
 - o Goal: MSOM is the preferred outlet of impactful OM research
 - o Plan:
 - more impactful OM articles (invite proposals for articles that explore new frontiers in OM and for OM survey papers),
 - more collaboration with MSOM Society,
 - more promotion/visibility (MSOM Review: online blog; press releases for some articles; re-blog using LinkedIn),
 - more communication (online blog from MSOM Editor; e-flyer to preannounce issues),
 - more constructive reviews,
 - more evaluation criteria (relevant, rigorous, and innovative),
 - more differentiation from Management Science and Operations Research,

- more recognition (petition for MSOM to be listed on the Financial Times list by 2017),
- less reviews (reduce the number of reviewers from 3 to 2, reduce the number of cycles to 2),
- less direct involvement (coordinate with MSOM Society on Best MSOM Award, and coordinate with INFORMS Office on quarterly statistics report).
- 13. President Serguei Netessine gave an update on the financial condition of the MSOM society. The ending balance as of July 31, 2014 was \$119,719. The organization is doing well in terms of financials.

 - To be eligible for consideration, publications must be nominated to the committee. Anyone may nominate a publication(s) (self-nominations are accepted).
 - To be eligible for the Year X iFORM SIG Prize (which is awarded in Year X) the publication(s) must meet the following requirements:
 - o It must be on service management
 - o It must have been published in a journal in Year X-3 or later
 - o It must have been written in the English language, and
 - o It must have been published in the open literature
- 15. President Serguei Netessine proposed a change in the award process of the M&SOM Journal Best Paper Competition
 - Proposed Change:
 - O To streamline the process, a committee will be appointed by the President of Manufacturing and Service Operations Management Society in consultation with the M&SOM Editor. The membership of the M&SOM 20XX Best Paper committee is as follows: XXXX.
 - Nominations for this award will be accepted until March 30, 2015. All papers published
 in one of the prior three volumes of M&SOM (Volumes 14-16) are eligible. Nominations
 should be mailed to the Chair of the M&SOM Best Paper Award Committee XXX (yyyyyy).
 All nominations will be handled as confidential input to be used only for the purposes of
 this award. Self-nominations are welcome.
 - The audience voted and approved the proposed change.

22. VP of Meetings Gal Raz presented the results of the survey on MSOM Conferences satisfaction

- More than 350 members answered our survey
- Overall people are happy with the conferences
 - o Almost 50% happy with number of participants
 - o 70% like the 3-page abstract submission
 - o 50% like the current fees (\$450 for regular and \$150 for students)
- Most members worried about conference growth
 - o 90% of people want 12 or less tracks
 - o 75% of people want 30% or less student participation
- Where should the conferences be?
 - 48.5% want conferences to stay in universities
 - o 7.9% want conferences to move to hotels
 - o 43.6% want to have both options
- MSOM international conferences
 - o 60% want to continue having the current schedule
 - o 32% like an additional international conference
 - o 28% like to move to an every other year model
