Recent UN regulations, such as UNECE WP29, have also fundamentally changed cybersecurity requirements for the automotive industry. OEMs now need to show evidence of sufficient cyber-risk management practices end to end (from design to post-production). The combination of huge amounts of new code, large supply chains and new cybersecurity legal regulations are going to force CISOs, their teams and VSOCs to operate in new ways to prevent, detect and respond to cyber threats. Cybersecurity will be increasingly important to both fleet and consumer purchase decisions.
