 - a) Previously served on the ISACA SA Chapter Board; and
 - b) Served on an ISACA International / ISACA SA Chapter Volunteer Committee;
 - c) Released thought leadership articles to ISACA International / ISACA SA Chapter;
 - d) Speaker at ISACA International / ISACA SA Chapter Events;
 - e) Sponsor at ISACA International / ISACA SA Chapter Events; and
 - f) Other involvement as an ISACA volunteer.
- 7) For the post of Treasurer, in addition to the above requirements.
 - a) a CA(SA) is preferred or relevant accounting qualification relevant to the position is required; and financial management experience. If you apply for this position, please indicate your qualifications and experience.
- 8) For the President and Vice President positions, in addition to the above requirements,
 - a) Past board performance will be considered. Specifically:
 - The candidate must have attended more than 50% of board meetings on the ISACA SA Chapter Board;
 - The candidate must not have resigned from a prior ISACA SA Chapter board mid-term; and
 - The nominations committee will consider other performance records, where available.
 - b) Previous participation on the ISACA SA Chapter Board is a prerequisite; without resignation or removal mid-term.

Now, therefore, it is resolved, that the criteria above shall be applied in terms of Article VI Section 1. B of the Chapter Bylaws.
