I understand my presentation must be submitted for review by the Event organiser no later than 2 weeks prior to the event. I understand the Event has limited capacity to support speaker or topic substitutions if a Presenter is unable to attend or perform duties of speaking at the Event. Any substitution for me will be considered on a case-by-case basis.

I understand and agree that presentations are to be an objective discussion that contributes to the body of knowledge relevant to ISACA members and the Event is not to be used as a sales or marketing platform. My materials will also be reflective of the current concerns, issues and regulations of the topic(s) that I am addressing. I agree and confirm the information contained in my presentation(s) or related presentation materials:

- 1. is factual and not misleading;
- 2. will not violate any obligation of confidentiality with third parties
- 3. will not violate the intellectual property rights of any third party; and
- 4. will not defame any third party; and
- 5. will not embarrass ISACA or its members .

I or my employer will retain all intellectual rights in the presentation content. I grant to ISACA Canberra a non-exclusive, royalty-free, worldwide license to use the presentation in the above context (License). Where the intellectual property rights are owned by my employer, I agree to procure a License from my employer to ISACA Canberra.
