Topic: "What do Statistics Tell Us about Cyber Resilience?"

Presenter: John South, CISSP, CISA

Description: One of the current topics of discussion is cyber resilience. We'll look at what cyber resilience means to a CISO and how we can use the security statistics that we see in the press. Whether internally or externally generated, statistics are something that we need to take the time to understand. What are the statistics trying to tell us? We'll look at a few of these numbers and try to get a picture of what they are telling us about crafting a resilient security and compliance strategy.

Bio: Recently John worked for NTT Ltd, as the head for the Global Threat Intelligence Communications Team. He also worked as a security consultant in his own firm. Prior to that, John worked as the CISO of Heartland Payment Systems from right after their breach until their purchase by Global Payments in 2015. He worked for Alcatel Lucent for 17 years as an ISO and CISO, a Systems Administrator, and various other jobs as needed. John has held the CISSP certification from shortly after the certification was initiated (21 years). John is also a certified UAV pilot (Part 107). He has completed a MGIS degree at Penn State with a specialty in photogrammetry and remote sensing (interpretation – he uses really cool helicopters with really neat cameras on them to take very sharp images and make very precise maps). He is applying for Ph.D. candidacy at two local universities.

- Understand that statistics about security can be interpreted in multiple ways
- Show how statistics can be used to craft security and compliance strategy
- Understand how we relate security statistics to cyber resilience
- Provide alternative ways of building a cyber resilient program

Presenter: Don Simmons

Bio: Don is an accomplished leader, strategist and business professional with wide-ranging experience in managing and directing large corporate security operations. His 30-years of professional experience includes security program development and administration, operations planning, internal controls, government/industry relations, disaster management & business recovery and staff development. Don earned a BS degree from UTA, Institute of Urban Studies in Criminal Justice, an Executive MBA from the UTD and completed an international business residency in Shanghai and Beijing, China sponsored by Grenoble Ecoli de Management, Grenoble, France. He served the country as commissioned officer in the US Army, Military Police Corp and the US Coast Guard. He is currently an Adjunct Professor at Columbia College, Columbia Mo. Where he teaches Crisis Management, Cross-Cultural Management, and International Business.

Description: According to recent studies, nearly 73% of persons who become violent at work share signals in advance with others. These signals may include overt agitation towards others, angry emails, voicemails or social networking posts. Effective identification of a person with risk factors can literally save lives. This presentation opens a portal from which to view and understand Security Threat Management.

ISACA North Texas Events Policy

The ISACA North Texas Chapter offers three types of fee based programs: Chapter Monthly Meetings, CISA® and CISM® Review Courses, and Seminars.

The chapter strongly encourages advance registration and payment for all events, as this reduces chapter expenses and the capacity for many of our events is limited due to the size of the event locations. Therefore, seats may not be available on the day of the event for walk-up registrants. The table on the final page of this newsletter summarizes the chapter's payment and cancellation policies.

Payment Policy

- All advance, online event registration payments will be made through CVENT. For advance, online registrations, payment is accepted via Visa, MasterCard, American Express, Discover and PayPal.
- Advance registrations will not be accepted after the time noted above unless otherwise noted in online event details.
- For walk-in registrations, credit card via Cvent, check, cash or Paypal payment is required.

Cancellation and Refund Policy

The North Texas Chapter of ISACA (ISACA NTX) strives to provide appropriate facilities for meetings, seminars and certification review classes. Since facility providers and/or speakers require advance notice and financial commitment, ISACA NTX must balance those obligations against our members' periodic need to cancel a reservation based on job requirements, illness or other circumstances.

Upon receipt of e-mail notification to reservations@isaca-northtexas.org, ISACA NTX will refund prepaid fee according to the following deadlines:

- Monthly Program Meetings cancellations must be received by 6:00 PM three days prior to the meeting.
- Certification Reviews cancellations must be received at by 6:00 PM eight days before the first class.
- **Seminars** cancellations must be received by at least one week prior to the first day of the seminar. If unusual cancellation terms are required based on speaker and/or venue, details will be included in the online event details.
