REGISTRATION TERMS AND CONDITIONS

Participation in 2024 ISACA Manila Conference is subject to the terms and conditions as specified in this document.

Financial Obligation of Delegate. Registration is on **FIRST-COME**, **FIRST-SERVED** basis. Upon receipt of registration form, an invoice will be sent detailing participation option and its inclusions. **Registration for the event is not confirmed until full payment is received.** The E-certificate will be issued to the paid delegate a week after the conference.

Issuance and Collection of Payment. All payments must be issued on behalf of ISACA Manila Chapter. Acceptable forms of payment are Cash, Cheque, PayPal or Bank Transfer. Collection is pre-scheduled and will be done by an authorized representative. Direct bank deposit is highly recommended. However, official receipt will only be issued following: (1) Delegate to email a copy of bank deposit slip validated by the transacting bank; (2) Confirmation from ISACA Manila Chapter's bank branch that payment has been duly received.

Early Bird registration and group discounts. Payments for the early bird registration must be paid in full on or before the mentioned date of discount, otherwise, the delegate will be invoiced with regular corresponding rates. ISACA Manila offers group 5% discount to organizations sending five (5) or more employees. **ONLY ONE DISCOUNT SCHEME APPLIES**. "No-shows" will be fully charged.

Cancellations, Refunds and Transfers.

- Cancellations must be submitted in WRITING.
- Cancellations notified on or before July 20, 2024 will be subject to a 50% cancellation fee. All fees are non-refundable after the cancellation date listed above. Registration fee refunds can only be issued after the conference has ended.
- All Refunds will be subject to 10% service charge. To initiate a refund, please contact ISACA Manila and email the received billing invoice.
- A member delegate can be replaced by another member. In case a member delegate is replaced by a non-member, the registration fee for non-members shall be applied and the new delegate will pay the difference in the registration fee.
- A non-member delegate can be replaced by a non-member in which the same rate applies. In case a non-member is replaced by a member, the excess registration fee paid will be refunded. The delegate should request for the refund by contacting ISACA Manila.
- The substitution of delegate should be done at least five (5) days before the conference.
- Cancellation for unpaid registered delegate. In case the registrant hasn't paid yet and wishes to cancel after July 20, 2024, he/she will be charge 50% of the total registration fee.
- No-show registrants will be charged 100% of the registration fee.
