

ISACA Belgrade Chapter Privacy Policy – Personsr Privacy Rights

Politika privatnosi Udruženja ISACA Beograd – Vaša prava na privatnost

This Privacy Policy describes how the ISACA Belgrade Chapter (“ISACA Chapter”) collects, uses, shares, and retains personally identifiable information persons provide. The Policy is effective as of 4th June 2019. The policy was last modified on 4th June 2019. This Privacy Policy applies only to information collected by Chapter. It does not apply to information collected or used by ISACA Global (“ISACA”) web sites, including (www.isaca.org), for the ISACA International Privacy Policy, please visit <http://www.isaca.org/pages/Privacy.aspx>).

This Privacy Policy also does not cover the practices of Chapter business partners (such as vendors, sponsors, or advertisers), nor does it apply to personally identifiable information that we collect from or about our employees, consultants, contractors, vendors, sponsors, or advertisers.

Modifications to this Policy

From time to time, Chapter may need to update or modify this Privacy Policy, including to address new issues or to reflect changes on ISACA web sites. To the extent required by law, Chapter will notify persons of material changes to this Privacy Policy, including by posting the most recent version of the Privacy Policy and information about the changes from the previous version on Chapter web site.

International Visitors

If persons are providing personally identifiable information and are not a resident of the Republic of Serbia, person country’s laws governing data collection and use may differ from those in the Republic of Serbia, in particular, the Republic of Serbia may not provide the same level of protections as those in persons own country. By providing information to ISACA Chapter, persons are transferring personal data to the Republic of Serbia, and persons consent to the transfer to, retention of and processing of persons data in the Republic of Serbia.

Collection of Personally Identifiable Information

Ova Politika privatnosti opisuje kako Udruženje ISACA Beograd (u daljem tekstu: Udruženje) prikuplja, koristi, deli i čuva podatke o ličnosti. Politika je na snazi od 4. juna 2019. godine. Politika je poslednji put izmenjena 4. juna 2019. godine.

Politika se odnosi na podatke o ličnosti koje prikuplja Udruženje.

Politika se ne odnosi na podatke o ličnosti koji se prikupljaju ili koriste na veb stranama ISACA Global-a („ISACA“), uključujući www.isaca.org (Politika privatnosti ISACA Global-a dostupna je na veb strani <http://www.isaca.org/pages/Privacy.aspx>).

Politika se ne odnosi na podatke o ličnosti zaposlenih, konsultanata, ugovarača, dobavljača, sponzora ili oglašivača.

Politika ne opisuje postupanje sa podacima o ličnosti od strane poslovnih partnera Udruženja (prodavaca, sponzora, oglašivača i sl.)

Izmene Politike privatnosti

S vremena na vreme Udruženje će možda imati potrebu da ažurira ovu Politiku privatnosti, uključujući i adresiranje novih zahteva ili da bi refletovala promene na ISACA web sajtu. U skadu sa zakonskim zahtevima Udruženje aktuelnu verziju objavljuje na svojoj veb strani, uz informacije o promenama koje su sprovedene u odnosu na prethodnu verziju.

Strani posetioci

Ako dajete lične podatke i niste stanovnik Republike Srbije, zakoni vaše zemlje koji regulišu prikupljanje i korišćenje ličnih podataka mogu se razlikovati od onih u Republici Srbiji i moguće je da Republika Srbija ne obezbedi isti nivo zaštite ovih podataka kao u vašoj zemlji. Davanjem ličnih podataka Udruženju, vi unosite ove podatke u Republiku Srbiju i pristajete na to da se vaši podaci dalje prenose, čuvaju i obrađuju u Republici Srbiji.

Prikupljanje ličnih podataka

Udruženje prikuplja i obrađuje razne lične informacije, koje uključuju: ime, prezime, identifikacioni ISACA broj, imejl adresu, telefonski brojevi, informacije o plaćanju, poslovne i kućne adrese, kao i demografske informacije

personally identifiable information, including: ISACA ID, email addresses, phone numbers, payment information, business and home addresses, as well as demographic information such as courses or areas of study in which persons may be interested]. Chapter collects information directly from persons through online registration forms, as well as offline, through exam or event registration forms. Information is collected and maintained from members, exam candidates, those who have been certified by ISACA, applicants, event attendees, speakers, participants in Chapter programs, purchasers of Chapter products and services, current and past web site users, survey respondents, and others. To the extent that information requested is not required for person's participation in a given Chapter program, persons will be told which information is optional. Should any persons fail to provide optional information, certain Chapter programs or features may not be available to it.

Chapter may also maintain information about persons that persons do not directly provide, whether it is information received from third parties, such as business partners who provide exam administration services, or information Chapter collects about person's activities. For example, Chapter keeps track of [list as appropriate: which events persons have attended, which exams persons have taken, which boards and committees persons have served on, and which offices persons have held].

Passive Online Data Collection

Chapter also collects certain information passively, such as collecting online, non-identifying information through the use of cookies technology and/or Internet Protocol ("IP") address tracking. Non-personal identification information might include the browser used by persons, the type of computer, the operating systems, the Internet service providers and other similar information. Most browsers are set to accept cookies. Persons can set to refuse cookies, or to alert persons when cookies are being sent; however, if persons disable cookies, the full functionality of our sites may not be available to persons.

Udruženje prikuplja lične podatke članova, kandidata za polaganje ispita, nosilaca ISACA sertifikata, aplikanata, učesnika događaja, predavača, sponzora, učesnika u anketama i drugim programima Udruženja, korisnici usluga Udruženja volontera koji nisu članovi, a koji učestvuju u projektima Udruženja i/ili volonterskim grupama, trenutnih i ranijih korisnika veb stranice, ispitanici i drugih. Ukoliko određeni lični podaci nisu neophodni za učešće u konkretnom programu Udruženja oni će, pri prijavljivanju za taj program, biti jasno označeni kao neobavezni (opciono). Ako opcione informacije nebudu date od strane neke osobe, toj osobi određeni programi ili funkcije Udruženja možda neće biti dostupne.

Udruženje može da čuva i obrađuje lične podatke koje nije direktno dobilo od lica na koje se ovi podaci odnose, već od treće strane kao što su poslovni partneri koji pružaju usluge održavanja ispita ili informacije koje Udruženje prikuplja o vašim aktivnostima. Na primer Udruženje prikuplja: na kojima si događajima prisustvovao, koje ispite si polagao, kom ste odboru ili radnoj grupi i firme koje posedujete.

„Pasivno“ prikupljanje podataka

Određene informacije Udruženje može da prikuplja putem interneta, korišćenjem tehnologije „kolačića“ i/ili praćenjem IP adrese i sl. To mogu da budu informacije o veb pretraživaču koji koristite, vrsti računara, operativnom sistemu, provajderu internet usluga, veb stranicama koje posećujete, linkovima koje koristite i sl. Većina pretraživača je podešena da prihvata „kolačiće“. Ako onemogućite „kolačiće“, moguće je da vam ne budu dostupne sve funkcionalnosti na našim veb stranama.

Na veb stranama Udruženja mogu se naći objave trećih lica koje sadrže „kolačiće“ koji prikupljaju vaše podatke ili imaju mogućnost da prate vaše ponašanje na internetu.

On the Chapter Site, not use certain third-party advertisers whose advertisements contain cookies that collect data from persons Chapter does not control the use of cookies by advertisers or third parties displaying data on the Site or on the sites persons visit using links from the Site.

Use, Sharing and Retention of Personally Identifiable Information

- Chapter uses personally identifiable information for the purposes described at the time of collection or as otherwise described to persons;
- to process persons requests;
- to report to others about whether persons are certified or not;
- as permitted by law to provide persons with information about Chapter, our products and services or other products and services in which we believe persons may be interested;
- for other legitimate Chapter business purposes, including order processing, processing of certification or membership applications, or registering persons for event or training programs.

Chapter may also use persons personally identifiable information to tailor persons experience at our sites, to compile and display content and information that we think persons might be interested in, and to provide persons with content according to such preferences Chapter also publishes the names, titles, country and business affiliations of officers, committee members and others who have assisted with initiatives or projects and activities.

Chapter may share personally identifiable information with third parties for legitimate business purposes, including for the following reasons or in the following circumstances:

- To vendors or third-parties who deliver or provide goods and services or otherwise act on behalf of or at the direction of ISACA Chapter, which third parties include, for example, exam testing agencies and training providers and partners, product-fulfillment companies, third-party event hosts, other third parties who may provide services on web sites that are accessible from links on one of our Site, and credit card companies processing

Udruženje ne kontroliše korišćenje „kolačića“ od strane trećih lica koja se oglašavaju na veb stranama Udruženja, kao i na sajtovima koje posećujete koristeći linkove postavljene na veb stranama Udruženja.

Korišćenje, deljenje i čuvanje ličnih podataka

- Udruženje koristi lične podatke u sledeće svrhe: da obradi zahteve za sertifikaciju ili članstvo;
- da obradi prijave za događaje, programe ili obuke u organizaciji Udruženja;
- da izvesti druge o tome da li ste sertifikovani ili ne;
- kada dostavlja informacije o Udruženju, njegovim proizvodima i uslugama, kao i drugim proizvodima i uslugama za koje proceni da biste mogli da budete zainteresovani;
- druge legitime poslovne svrhe i svrhe navedene u trenutku prikupljanja podataka.

Udruženje takođe može da koristi vaše lične podatke za prilagođavanje sadržaja sajta vašem iskustvu, za kompajliranje i prikazivanje sadržaja i informacija za koje misli da bi vas mogle interesovati, kao i da vam pruže sadržaj prema takvim preferencijama.

Udruženje može da objavi lične podatke (ime, zvanje, poslovne podatke) svojih službenika, članova odbora i drugih lica učesnika u inicijativama, projektima i aktivnostima Udruženja.

Udruženje može da deli lične podatke sa trećim licima za legitime poslovne svrhe, i to:

- trećim licima koja isporučuju robu i usluge ili na drugi način sarađuju sa Udruženjem, kao što su centri za polaganje ispita, organizatori obuka, izdavaoci prostora za događaje, pružaoci usluga na veb stranama koje su dostupne preko linkova na našim veb stranama, procesorima platnih kartica i sl.;
- volonterima i članovima Upravnog odbora Udruženja;
- koordinatorima programa u organizaciji ISACA Global-a, drugih ISACA ogranaka, Instituta za IT Governance i sl. u kojima učestvujete;
- ako ste učesnik, govornik ili sponzor na događajima u organizaciji Udruženja određene informacije o vama mogu biti javno objavljene u agendi događaja;
- radi istrage potencijalno lažnih ili sumnjivih aktivnosti;

- To Chapter volunteers and board members;
- To ISACA and other ISACA chapters, the IT Governance Institute, and if persons participate in our "Enterprise Participation Program," persons information will be shared with persons organization's program coordinator;
- If persons are an event attendee, speaker, or sponsor, certain of persons' information will be included in the event roster, which roster will be publicly disclosed, and may also be shared with third-party event sponsors and exhibitors;
- To investigate potentially fraudulent or questionable activities;
- In anticipation of and in the course of an actual or potential sale, reorganization, consolidation, merger, or amalgamation of all or part of our business or operations; and
- When we believe it is necessary to cooperate with law enforcement or in response to a government request, including if specifically requested or required, as otherwise permitted by law, and for other valid Chapter business purposes.

Chapter also may use persons profile information on an aggregate basis – without personal identifiers – to provide third parties with information, such as to help us develop new features and content for the Site, and to provide Sponsors and others with aggregate information about our users and the usage patterns of the Site. Chapter retains personally identifiable information for as long as necessary for its legitimate business purposes, and as otherwise permitted by applicable law.

Security

Chapter uses reasonable measures to safeguard sensitive personally identifiable information, which measures are appropriate to the type of information maintained, and follows applicable laws regarding safeguarding any such information under our control. In addition, in some areas of our Site, Chapter may use Secure Socket Layer ("SSL") or Transport Layer Security ("TLS") encryption technology to enhance data privacy and help prevent loss, misuse, or alteration of the information under Chapter control.

Bezbednost

Udruženje primenjuje razumne mere za zaštitu osetljivih ličnih podataka, u skladu sa zakonom.

Kako bi se unapredila zaštita ovih podataka i sprečio njihov gubitak, izmena, ili zloupotreba, Udruženje, na pojedinim veb stranama, može da koristi Secure Socket Layer ("SSL") i Transport Layer Security ("TLS") tehnologiju.

Međutim, Udruženje ne može da garantuje sigurnost vaših ličnih podataka na internetu. Upozoravamo vas da budete oprezni kada ostavljate svoje lične podatke.

Linkovi ka veb stranama trećih lica

Udruženje vam može, kao uslugu, ponuditi linkove ka veb stranama trećih lica. Neke reklame će takođe sadržati linkove ka ovim veb stranama.

Ovim veb stranama upravljaju nezavisna lica koji imaju sopstvenu politiku privatnosti.

Politika privatnosti Udruženja ne odnosi se na ove veb strane i ne uređuje korišćenje vaših ličnih podataka od strane tih lica.

Udruženje nema kontrolu nad sadržajem koji se prikazuje, niti nad merama za zaštitu vaših ličnih podataka na ovim veb stranama.

Chapter cannot guarantee, however, that persons information will remain secure. The Internet by its nature is a public forum, and Chapter encourages persons to use caution when disclosing information online. Often, persons are in the best situation to protect persons self-online. Persons are responsible for protecting username and password from third party access, and for selecting passwords that are secure.

Links to Third-Party Sites

From time to time, Chapter will provide links to third-party web sites, or advertisements will contain links to third-party sites. For example, Chapter may link to a third party who is assisting in or is providing online training services. These links are provided as a service to persons. These sites are operated by independent entities that have their own privacy policies. ISACA Chapter's Privacy Policy does not apply to such other sites or to the use that those entities make of persons information. Chapter has no control over the content displayed on such sites, nor over the measures, if any, that are taken by such sites to protect the privacy of persons information.

Persons Privacy Rights Relating to Certain Information Disclosures

Persons can request from the Chapter:

- a list of persons personal data stored and processed Chapter;
- a list of persons personal data provided to third parties;
- a list of third parties to whom persons personal information has been provided.


