



Policy: Artificial Intelligence (AI) Usage for KDP application submissions by members and non-members.

Effective: January 30, 2026 (updated 2/10/26)

Your story matters. We want to hear *your* ideas, experiences, and perspective. We recognize that some applicants may use AI tools (like ChatGPT, Grammarly, Claude, or similar) to support brainstorming or editing. That can be okay—within limits.

What's required

1. **Primary authorship:** The essay must be written in your own words and reflect your own experiences and viewpoints. Photos and videos must be authentic.
2. **Truthfulness:** Any claims about your background, accomplishments, service, or experiences must be accurate and verifiable.
3. **Disclosure:** You must briefly disclose any AI assistance used.

Acceptable AI use (allowed)

- Brainstorming topics or outlining ideas
- Generating questions to help you reflect (e.g., "What challenges have I overcome?")
- Grammar, spelling, clarity, and tone suggestions
- Basic feedback like "make this more concise" *using your own draft as the source*
- Edit photos or videos (e.g., retouching, cleanup, or color correction)

Unacceptable AI use (not allowed)

- Having AI write the text or substantial portions (more than 10%) without using your original ideas
- Using AI to fabricate experiences, achievements, quotes, stories, or data
- Rewriting someone else's essay (or a template) via AI to make it look original
- Using AI to fabricate photos or videos

AI Verification: KDP reserves the right to utilize AI detection tools. Failure to adhere to the KDP Member AI Use Policy may result in disqualification.

Submissions must be the original work of the author(s). Any use of AI for writing assistance, including but not limited to drafting, rewriting, or paraphrasing, is not permitted.

Author must confirm one of the following required options:

- I confirm that no generative AI tools were used in the creation of this manuscript.
- Generative AI tools were used to prepare this manuscript. (Please disclose in the next question)

AI Disclosure Statement

If you indicated AI tools were used in the question above, please disclose which tools were used (e.g., ChatGPT, Claude, Bard, etc.) and how they were used (e.g., brainstorming ideas, improving language, research assistance).
