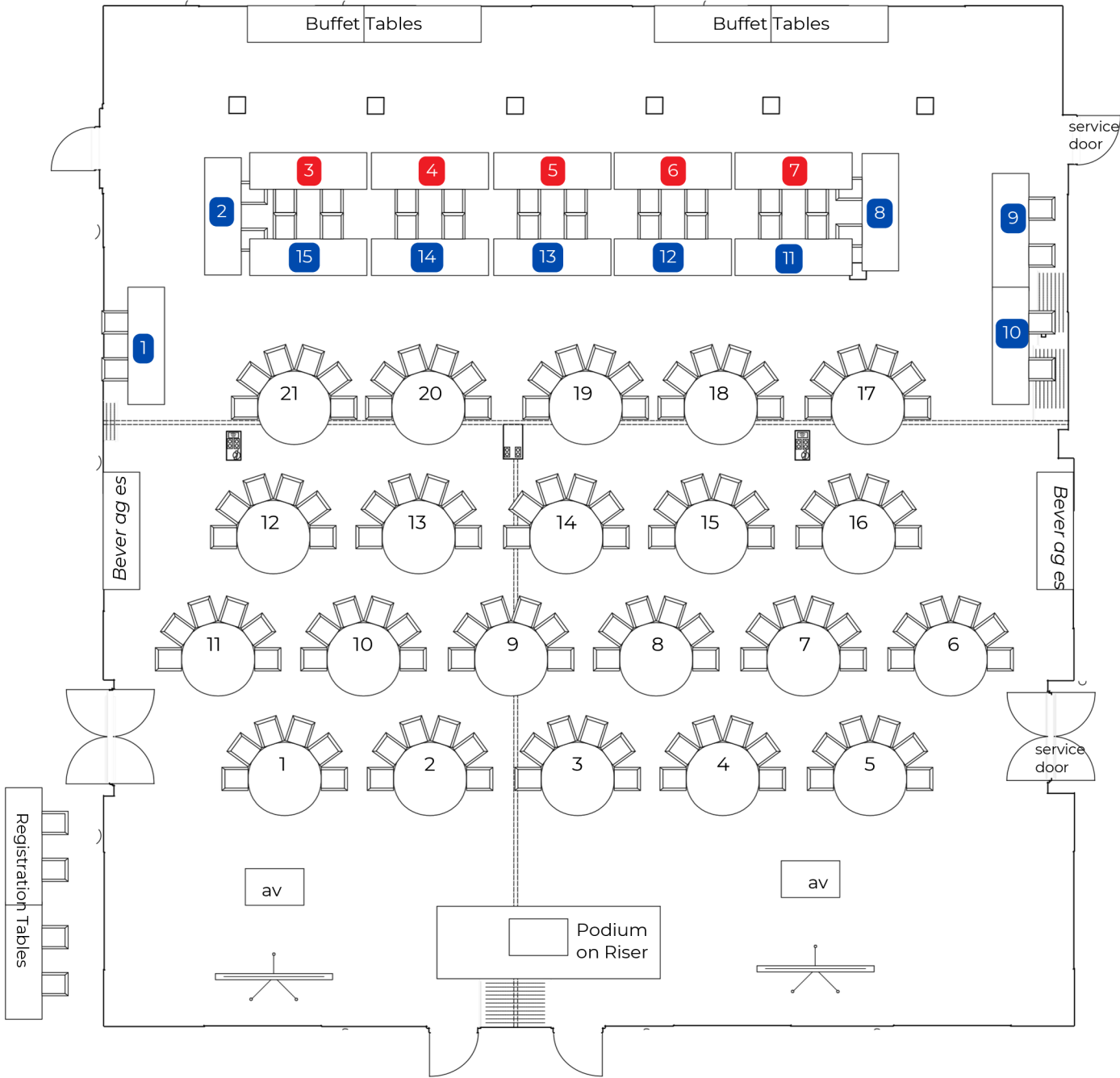

Booth Staffing & Exhibitor Conduct

- No exhibitor may sublet, assign, or share any part of the space allocated without the consent of Big I Michigan.
- Exhibit tables must be staffed during all exhibit hours by qualified employees of the exhibitor, who must be able to explain or demonstrate the products or services on display. Products or services must be related to the insurance industry.
- The rights and privileges of an exhibitor shall not be infringed upon by any other exhibitor. To ensure adequate staffing, while limiting the probability of intruding upon others' space, each booth is limited to two representatives.

Cancellation & Refund Policy

- Refunds (minus a \$500 administrative fee) will be granted for cancellations received in writing, prior to Sept. 1st, 2025.
- Cancellations received Sept. 1 through Oct. 15 will be assessed a fee equal to 60% of the exhibit cost.
- Refunds will not be granted due to inclement weather, cancellations received after Oct. 15, no-shows or the event being rescheduled for a later date. Refunds will be granted only if the event is cancelled.
- Any exhibitor failing to occupy contracted space is not relieved of the obligation of paying the full rental of such space. If a table is not occupied by the opening of exhibits for attendees, Big I Michigan may repossess exhibit space.
