D. Council on Legal Education Opportunity (CLEO)

At our last meeting, Dave Berry made a request that IPLS provide a grant to the CLEO, a summer program for diverse/underprivileged undergraduate students, to introduce them to law school. In the past, it was supported through ABA and federal funds. That was lost. Last year it was supported by Cooley Law School, Oakland University, and various state bar sections, law firms, bar associations, and others.

At our last meeting, Dave Berry requested that the Section consider making a \$1,250 grant to CLEO. The Council had questions, primarily focused on whether such a grant was consistent with our mission statement.

Dave Berry reported as follows;

Did any of last year's students have a technical background? No, but 3 of the 20 students from last year expressed an interest in entertainment and sports law.

Is there any way the students could be given information on IP careers? Yes. Dave Berry would volunteer to provide an overview of IP law and careers to the students. to Part of the program involves overview of legal careers.

<u>Motion:</u> By Joellen Shortley to grant \$500.00 to support the CLEO program with the understanding that David Berry will speak on patent, trademark, and copyright law and careers in those fields. Seconded by Kristin Murphy. Passed unanimously.

David Berry will work with Adam Strauss to provide the necessary information for the grant.
