Spring Seminar 2012

The Council continued to work on topics and speakers for the Spring Seminar, which will be held at the Kellogg Center in Lansing on March 26, 2012. Adam B. Strauss and Kristen Isaacson Spano will moderate the two program tracks.

The ICLE has requested USPTO for both patent and trademark talks. The ICLE has also invite a Patent Trial and Appeals Board judge to speak on new rules under the AIA or on winning briefs for the PTAB. Speakers have been confirmed for these topics” America Invents Act from the perspective of a patent attorney; section 101 issues; cloud computing; speakers for panels for an Automotive Industry track, a Life Sciences industry track, and a Financial Industry track (a third panelist remains to be confirmed). A speaker is needed for the topic of the new gTLDs. Karl Ondersma will invite a luncheon speaker.

The Council decided to not have a student roundtable in the hour before lunch so that the students could attend the patent or trademark track talks then.

Miller Canfield will sponsor the materials and USBs.

The deadline for marketing materials (program publication) is October 30. Stephanie Stenberg needs to have the final plans by October 21 to pull the materials together.

Summer IP Institute 2012

The Summer Institute will be held at the Grand Traverse Resort in Traverse City on July 19-21, 2012.

Speakers for advanced topics for Thursday and for the updates Friday morning have been confirmed except for ethics. Speakers are also confirmed for the topic what European oppositions can teach us about the new post-grant review; secondary liability for trademark and patent infringement; and first sale doctrine for imported goods. A speaker has been invited to speak on corporate espionage; a speaker is needed for the topic of secondary markets.
