- Alternative to HB 4691. An Ad Hoc Committee was 1. created for the purpose of drafting an alternative to HB 4691, and Barb Kelly was appointed the Chair of this Ad Hoc This project is being moved out of the Committee. Legislative Committee because the time investment and work necessary to create an acceptable alternative is leaving the Legislative Committee with inadequate time to focus on There are two competing other legislative proposals. approaches to how the alternative bill should be drafted, and this Committee will work on reconciling these approaches to provide one acceptable recommendation to Council; at that time, Council will vote on whether to approve or decline the Committee recommendations. See Barb Kelly if you would like to be on this Committee.
- 2. HB 5359. This bill seeks to require foster children to have psychiatric screening prior to placement for adoption. Jim Chryssikos made a motion that Council support this bill. Tina Yost-Johnson seconded the motion. Council voted 18-0 to support the motion.
- 3. HB 5415. This bill seeks to require both spouse to consent to a conveyance of a primary residence. Jim Chryssikos made a motion that Council support the concept of this bill, but that some of the language be modified because there are concerns about how this bill might create confusion for real property and title rights. Liz Bransdorfer seconded the motion. Council voted 18-0 to support the motion.
- **4. HB 4272.** This bill would authorize township supervisors to perform marriages. Council declined to take a position on this bill.
