MINUTES – FAMILY LAW SECTION COUNCIL MEETING Date: 10/13/2018

I. Administrative matters

A. Call to Order/Quorum and Welcome

The Council was called to order by Bob Treat.

B. Introduction of Attendees

C. Chair Report

- 1. The FLC Attendance policy was reviewed. No more than 2 unexcused absences per year.
- 2. The FLC Expense Reimbursement policy was reviewed. \$700 per person maximum per year. Reimbursement includes travel distances of 50 miles or more each way, and hotel reimbursement for one way travel of 100 miles or more one way.
- 3. Article Writing Policy was reviewed. Each council member is responsible to write one article during their term. Email articles to Amy Spilman and Anthea Papista, co-chairs of the Family Law Journal.
- 4. A special election will be held in November due to the resignation of Kent Weichmann. The special election will directly follow the Family Law

Institute at the Suburban Showplace in Novi, Michigan in November 2018. Those interested in running, please email your completed application form to Elizabeth Bransdorfer or Sahera Housey.

- 5. Bylaws. The Bylaws were generally discussed. All are encouraged to read the Bylaws and subsequent amendments which will be posted to the section website once collected. Section 4.3 affords the Chair all rights and privileges of Council membership during that term of office, including the right to vote. Proposed Bylaw amendments must be in writing, in the form of a Petition signed by at least 10 members at least 60 days prior to the annual meeting. Article IX.
- 6. Annual meeting. The FLC annual calendar was reviewed. The year concludes with the annual meeting in September, when new members are elected to fill expired council member terms. Reminder to attend the annual meeting, the last meeting, to avoid application of the attendance policy (no more than 2 unexcused). The first council meeting for the new term immediately follows the annual meeting, at which which officers are elected for the new term. This first council meeting counts towards attendance in the new term. See back of Meeting Agenda where dates and locations of all meetings for the term are listed.
- 7. Name plates for Council Members elected at the annual meeting will be ready for the November 2018 meeting.

II. Key Committee Reports

A. Amicus-Ann Argiroff/Gail Towne

The committee is working on completion and filing of the *Dorco* amicus brief, council's position was previously adopted. (application of the statute of limitations in QDROS). The committee is evaluating a request for an amicus brief in *Ferris v McKay* (whether Lawyer GAL can be sued for legal malpractice).

The committee was invited to submit an amicus brief for In re MGR, minor (an adoption appeal).

B. Court Rules-Jenny Johnson/Peter Kulas-Dominguez

1. <u>ADM File 2017-20.</u> This is a proposed rule change on what orders constitute a final order appealable by right. A public administrative hearing was held by the S Ct on 9/20/2018. The Supreme Court limited appeals by right to only custody, legal custody and domicile, adopting the more restrictive COA position.

The committee recommends an article in the FLJ to create awareness about the rule change.

A motion was made by Chris Harrington and seconded for the committee to prepare correspondence on behalf of the FLC to the Supreme Court requesting that ADM file 2017-20 be reopened for public comment and to hold the order in abeyance for period of time.

Council discussed procedural irregularities, problematic application of the new rule, e.g. custody motion titled as a parenting time motion, among other issues. The Appellate practice section may also communicate to the Supreme Court on the rule change.

Council voted 19 unanimously in favor of this motion.

- 2. A 53 page proposal containing a series of rule changes effecting e-filing is being reviewed by the committee and will be addressed at the next meeting.
- 3. <u>ADM 2018-03</u>. The Supreme Court used much of the language suggested by the Collaborative Divorce committee adopted by council in its integration of collaborative law into the state's trial court system. The council had an impact.

C. Legislation-James Chryssikos/Randy Velzen

- 1. <u>HB 6233.</u> Bill to amend MCL 551, sections 2, 3 and 9 to remove language that marriage is a civil contract between a man and a woman and to make the act gender neutral, but remaining prohibition against marrying relatives. Gender neutral. **Motion by Jim Chryssikos, and seconded to support the bill.** Discussion. **Motion passed 19 unanimously in favor.**
- 2. <u>HB 6234.</u> Bill to remove the prohibition of same sex marriage from foreign marriage act, to recognize valid marriages from other state between two individuals. **Motion by Jim Chryssikos and seconded to support the bill. Discussion held. Motion passed 19 unanimously in favor.**

- 3. <u>HB 6235.</u> Bill to amend secret marriage act to remove reference to "a person of the opposite sex" and other minor revisions. **Motion by Jim Chryssikos, seconded to support the bill. Approved 19 unanimously in favor.**
- 4. House Joint Resolution LL: Resolution to amend the state constitution to remove the constitutional prohibition of same sex marriage and civil unions and put on ballot for statewide vote. Motion by Jim Chryssikos, support by Kent Weichmann to support the bill. Discussion of pros/cons of putting the issue on the ballot in light of the Supreme Court decision of Obergefell. The issue would not be on the ballot until 2020. Motion by Jim Chryssikos and seconded, to support the HJR LL. Motion passed, 17 in favor, no opposed, 2 abstain.
- 5. <u>HB 6229.</u> A bill to permit 2nd parent adoption of 2 unmarried persons. Section supported the bill prior to Obergefell, then after questioned whether needed 2 married to adopt. Motion to oppose HB 6229 by Jim Chryssikos, second by Kent Weichmann. Discussion held of unique fact pattern. LGTBQ committee not in favor of creating separate classes, same treatment as heterosexual peers.

Motion to oppose HB 6229 by Jim Chryssikos and seconded. Motion passed. 16 in favor, no opposed, 3 abstain.

- 6. <u>HB 6409</u>. A bill to authorize secular celebrants to solemnize marriages with training. Previously took no position on bill to permit city managers to solemnize marriages. Legislative committee recommended not taking a position on this bill. No vote taken.
- 7. <u>Secret Marriage</u> Act. Council previously supported proposing legislation to prohibit child marriage under age 18 under Secret Marriage Act. Discussion Senator Emmons supportive but may term out. Council may consider finding another legislator to advance this legislation if not advanced prior to the election.
- 8. <u>Post Judgment Arbitration.</u> Council previously voted 19/0/1, in support of post judgment arbitration of personal property. A proposed bill has been approved by Council. Stephanie suggested finding a sponsor once committee assignments are made in January 2019.
- 9. <u>HB 4691</u>. Committee had questions about the bill's status, next steps regarding alternate bill. Discussion tabled to Alternate Custody bill discussion on Agenda.

D. Alternate Custody Proposal-Barb Kelly

1. Finalization of form of Simple Bill.

Stephanie Johnson provided a legislative status report and provided recommendations.

Motion by Sahera Housey and seconded to add to previously approved simple bill the presumption that it is in the best interests of a child to have a strong relationship with both parents, as presently contained in the parenting statute, SCAO to include the additional language in the Summons notice provisions.

Lengthy discussion held.

Motion passed, 18 in favor. 1 opposed in present form, no abstensions. Motion passes.

2. Motion by Sahera Housey and seconded to circulate approved simple bill as amended to all stakeholders to gauge support. Discussion held.

Motion passed 18, 1 opposed, no abstensions.

- 4. Committee is discussing the Senate Bill 4751, the Klint Kesto Bill on prenuptial agreements.
