# MINUTES - FAMILY LAW COUNCIL COUNCIL MEETING

#### I. Administrative Matters

A. Chair Rebecca Shiemke called Council to order.

- B. All attendees introduced themselves
- C. Chair Report Rebecca Shiemke announced that the Blaine Johnson award will be awarded posthumously to John Mills at the Family Law Institute. She also moved that the cost for the Family Law Journal for non-members be changed from \$33 to \$50, which passed 17-1. Rebecca announced the new State Bar website, "State Bar Connect," which will replace the current web site. She also announced Chris Harrington as a member of the Michigan Lawyers Weekly "Up and Coming" class of 2014.
- D. Recording Secretary Report/Minutes No Report.
- E. Treasurer's Report/Finance Committee Rebecca Shiemke appointed Dick Halloran chair of the Budget Committee. The budget committee recommended approval of expense reimbursement up to \$150 limited to twice per year to include accommodations, parking and mileage for travel of 100 miles, and a motion was made. The motion passed 18-0.

- B. Court Rules Co-Chairs Mathew Kobliska and Chris Harrington.

  Mathew Kobliska moved to adopt amending rules per the joint effort with the Court Rules committee and the ADR Committee, such rules

being 3.203, 3.205, 3.206 and 3.210 regarding captioning of certain domestic relations cases. After considerable discussion, the motion passed 13-5. As to ADM 2014-12, Mathew moved we support allowing parties to stipulate to post judgment arbitration, consistent with our past support. The motion passed 18-0. Regarding ADM 2014-37, Chris Harrington discussed briefly the issue of emergency removal of a child, but suggested that we defer to the Children's Law section on the ADM. Regarding MCR 3.215 and the recommended improvements in some counties' FOC hearing recordings, Chris Harrington moved that the council approve the amendment to the rule, and the motion passed 18-0.

C. Legislation – No Report. There was discussion about SB 981 and the need to write letters to the appropriate representatives.

- D. CLE/ICLE Liz Bransdorfer announced that ICLE is looking into removing old content that tends to clutter searches and the website, if such content is more than three years old.

A motion was made to amend the by-laws at the next annual meeting to make free membership for new attorneys one year instead of two, and to made law student membership free. The motion passed 18-0. There was discussion about prorating our dues for joiners who join part way through the year. Dick Halloran said he would investigate the feasibility of this with contacts at the SBM. There was a reminder that we will have a table set up at the annual Family Law Institute, and we'll need volunteers to stop by and tend the display for a time, so that it is not unattended. Chris Harrington discussed a possible meet-up in the evening, and will advise further.
