#### B. Court Rules

Mathew Kobliska (for Chris Harrington) discussed proposed Amendment to MCR 3.216 which deals with domestic relations cases that also included a Personal Protection Order.

Proposed Amendment to MCR 3.216 - Mat made a motion to adopt the revisions and they were seconded by Kent. Liz B made a friendly amendment to add "After a hearing", the court may order mediation if a protected party requests mediation. The friendly amendment was seconded by Kent.

Proposed Amendment to MCR 8.216 – this would allow out-of-state counsel to appear more easily in Indian child cases. Motion was made by Mat, seconded by Kent and passed. 1 opposed and 2 abstentions.

Mat Kobliska also discussed that the audio and video recordings of hearings apply to FOC hearings also.

Mat Kobliska discussed the State Bar of Michigan's Special Committee on Civil Discovery Court Review.

Anne Argiroff discussed Amendment to MCR 7.213 – the comment period is until January 1, 2017. (also in Amicus)

# C. Legislative

Kent reported on the Shared Parenting Bill/Revised HB 4141. The Section has been working on this issue for months and has a committee to review the bill. Council wants to work with the legislators to assist with revisions to this bill. Council has been actively seeking information and a survey around the state from attorneys, judges and parties to get input on how this legislation impacts Michigan families and children.
