#### I. Administrative Matters

- A. Call to Order: The meeting was called to order at 9:30 a.m.
- B. Chairperson's Report:
  - Note that the agenda includes the annual meeting date and time and information regarding the summer and winter seminars.
  - Asking for a showing of hands, the majority of those present are on Linked In.
- C. **Recording Secretary Report** Minutes from the January 28, 2012 meeting were unanimously adopted.
- D. **Treasurer's Report** The Treasurer's report was unanimously adopted.

## **II.** Standing Committee Reports

- A. **Amicus.** Council voted 17-0 to submit an amicus brief supporting the Court of Appeals decision in *P v Zajackowski*.
- B. Court Rules.
  - MCR 3.213 Council voted 17-0 to support an amendment to MCR 3.213 to add the following sentence at the end: "...and discovery under subchapter 2.300 is available while post judgment motions are pending."
  - MCR 2.117 The committee will review possible revisions to postjudgment appearance under this court rule.
  - **ADM file 2010-22** A public hearing is scheduled for March 27, 2012 regarding the anti-trolling provision. Anyone interested in participated should contact Jim Harrington.

### D. Legislation.

- **HB 5328** Council voted 17-0 to support HB 5328, which amends the Acknowledgment of Parentage Act to provide that revocation is governed by the Revocation of Paternity Act (RPA).
- **HB 5329** Council voted 17-0 to support HB 5329, which amends the Paternity Act to provide that revocation is governed by the RPA.
- SB 989 Council voted 17-0 to oppose SB 989, which would prevent courts from awarding any parenting time to a parent if anyone in that parent's household is convicted of a felony requiring them to register under the Sex Offenders Registration Act, unless the other parent and the child agree to the parenting time. Rather, council suggests that i might be

useful to create a protocol for handling this type of case. The SCAO has a manual for Custody and Parenting Time Evaluations that discusses factors for parenting time. Page 13 of the Parenting Time Guidelines begins the discussion of supervised visitation. These could be updated to include specific sections for evaluating cases where a parent has been convicted of inappropriate behavior with a minor. It would also be possible to add a factor to the parenting time statute, MCL 722.27a, to give the court more specific direction in these cases.

- **SB 1000** Council voted 17-0 to oppose SB 1000, which would prevent the court from allowing parenting time to occur in any country not party to the Hague Convention, and instead suggest the Uniform Child Abduction Prevention Act approach as an alternative.
- **Sealing court** files Council agreed to continue to review proposals to seal domestic relations files. It was suggested that cost could be a factor and Council is interested in investigating this issue.
- F. **Alternative Dispute Resolution.** A written report was circulated detailing the committee's work.
