C. Chair Report:

1. Kent discussed the State Bar program called the "Modest Means" program. This program is designed to make legal representation more available to people who are disqualified from Legal Aid programs because they make too much money ("lower middle class"), but whom don't have much in the way of disposable income or other economic resources to retain counsel. This program is in the very early stages of planning and discussion. Steve Reinheimer, Peter Kulas-Dominguez, Colleen Markou, and Jennifer Johnsen volunteered to get involved with this program.

Chris Harrington made a motion to approve the January 20, 2018 minutes. The motion was seconded by Liz Bransdorfer, and was passed.

A motion was made to approve the Treasurer's report. There was a comment that the Journal might have a double entry, and if so, this will be cleared up. A report of dues-paying members in the Section was also submitted. Sahera Housey seconded the motion to approve the report and Council voted in favor of the motion.

B. Court Rules –

This proposal would re-define 1. ADM File No. 2016-49. "prospective client" by creating a new MRCP 1.18 "Duties to Prospective Client." This rule will help clarify the relationship between an attorney and a person who has not yet retained the attorney. This rule will also clarify the standards for an attorney being disgualified from representing a client if they have only met with the person as a prospective client, including issues "intentional disqualification" when a prospective client is meeting with a number of lawyers for the sole purpose of disqualification. The Committee recommended this proposal be supported. Chris Harrington made a motion that the Council support this rule proposal, with a couple minor modifications. Council voted 17-2 to support the motion.
