MINUTES – FAMILY LAW SECTION COUNCIL MEETING

D. Approval of Minutes

Chris Harrington made a motion to approve the April 7, 201 8 minutes. The motion was seconded and was passed.

E. Treasurer's Report/Finance Committee

A motion was made to approve the Treasurer's Report. The motion passed.

II. Key Committee Reports

A. Amicus – no report

B. Court Rules -

1. ADM File No. 2017 -20. This proposal seeks to clarify what constitutes a final post -judgment order in a domestic relations case for purposes of appeal by right. This would modify MCR 7.202(6)(a)(iii) so that a "final order" includes: "a postjudgment order that, as to a minor, grants or denies a motion to change legal custody, physical custody, domicile, parenting time, grandparenting time, school enrollment or religious affiliation; or authorizes or denies medical or mental health treatment." The current law only allows an appeal of right for cases that "affect custody."

This is a proposal that family law appellate practitioners have been seeking for a number of years. It was stated at the Committee meeting that the proposal is effectively how the appellate rules used to be written. There is excessive litigation and costs spent on what issues " affect custody." This rule would seem to clear that up.

Recommendation to Council: Council voted 18 -0 to support the amendment as written.

2. **Court Rules Co-Chair.** Jennifer Johnsen has been appointed Co -Chair of the Court Rules Committee.

C. Legislation –

1. **HB 4891**. This proposal would decriminalize eavesdropping by a parent against their minor children, with some specific exceptions. The Committee recommended that the bill be

supported with some adjustments to one of the exceptions. After a friendly amendment was made, but not accepted, council voted to "table" this to the next meeting to work on some amendments to the proposal and bring it back to Council for a new vote.

2. SB 937. This bill creates a new act to be known as the "extreme risk protection order act" allowing seizure of a defendant's firearms on an expedited (*ex parte*) basis. The Legislative Committee recommends that Council support this bill. After discussion and a vote, Council did not support this bill, with a vote of 4 in favor, 11 opposed, and 1 abstention.

D. Shared Parenting Bill

1. Barb Kelly provided an update on the status of this Committee, which has evolved into two competing approaches for a custody/shared parenting bill which would serve as an alternative to HB 4691. For purposes of the vote at this Council meeting, and to provide a reference label to these two tracks, the first track is labeled the "Comprehensive bill" and the second track is labeled the "Simple bill.

Barb Kelly requested a vote from Council to give a recommendation on which track should be pursued, drafted in final, and brought to Council for a vote.

There was an extensive discussion on the pros and cons of each track. A majority of Council members and guests provided input and comments on what may be the best approach.

Council voted to 12 -6 to direct the Committee to pursue the "Simple" bill option. Barb Kelly hopes to have the Committee prepare a draft for Council review at the next meeting.
