## D. Approval of Minutes

Chris Harrington made a motion to approve the May 5, 2018 minutes. The motion was seconded and was passed.

## E. Treasurer's Report/Finance Committee

A motion was made to approve the Treasurer's Report, subject to a misallocation of "plaque & recognition" funds. The motion passed.

### C. Legislation –

- 1. Senate Joint Resolution Q. There is a proposal to amend the state constitution to require consideration of the best interest factors in all termination cases, custody cases, and out-of-home placement cases. A motion was made to oppose this proposal. After discussion, the Legislative Committee gave a thorough review and recommended that Council oppose it because this is an issue that would better be handled by statute, and not through an amendment to the state constitution. Council voted to support this motion 17-0 (one voting member was not available at the time of the vote).
- 2. HB 4891. This proposal would decriminalize eavesdropping by a parent against their minor children, with some specific exceptions. Since the last meeting, the Legislative Committee has made some adjustments to the proposed language regarding the label of the "parent", and whether it should read "custodial parent" or just "parent." A motion was made that section (E)(iii) of the bill should read "The other <u>custodial</u> parent, unless authorized by a court." The motion was seconded, and Council voted to support the motion by a vote of 11-5-2.
- 3. Child Marriage Law. The Legislative Committee discussed the issue of child marriage at its meeting, and a motion was

made to the Council seeking approval for the Committee to work on drafting a proposal to amend the current laws on child marriage. Council voted in favor of this request, and the Committee will add this item to its agenda for the upcoming 2018-19 year.

### D. Shared Parenting Bill

The Committee is working up its draft of the "Simple" version of an alternative piece of legislation to HB 4691.

A motion was made to add language of a "Notice Requirement" which would mandate the court to provide notice to both parties of their rights under the law on pursuing custody. The motion was seconded. The Committee was undecided on the most appropriate placement of the notice requirement – Summons, Statute, Court Rule – and was seeking Council's input on placement and content of this language in the alternative legislation. Council provided some feedback on the substance of this language and voted unanimously to support the inclusion of a notice requirement and to let the Committee develop where this notice will appear.
