MINUTES – FAMILY LAW SECTION COUNCIL MEETING

I. Administrative matters

B. Chair Report:

Kent welcomed everyone on behalf of Richard Halloran who was unable to attend the meeting.

Kent explained the latest with deportation and enforcement at courthouses for witness or parties. Kent made a motion to sign on a letter objecting to this. Dan Bates seconded. The motion passes 13-3. Only 16 members were present at the time of this vote.

Kent also provided the dates for next 2017-2018 council meetings.

The October meeting will be held at the Hotel Indigo in Traverse City instead of Park Place as indicated in printed schedule.

C. Approval of Minutes

Sahera Housey made a motion to approve the May 6, 2017 minutes. Liz Bransdorfer seconded and the motion passed.

D. Treasurer's Report/Finance Committee

Bob Treat was not present and Liz Bransdorfer made a motion to table Bob's report. The Motion passed.

E. Corresponding Secretary

Liz Bransdorfer discussed the monthly article in the State Bar Journal and requested that if anyone has any ideas or topics for the article she writes on behalf of the section for the Michigan Bar Journal to please forward them to her.

II. Key Committee Reports

A. Amicus

The Amicus committee reported they are working on Allard issue. Another case similar to Allard is waiting to see if leave to the court of appeals is granted.

B. Court Rules

Chris Harrington reported on the following:

- 1) ADM File No. 2016-41 (MCR 1.0, 1.2, 4.2 and 4.3. MCR 2.107, 2.117 and 6.001). This addresses unbundling of legal services, limited scope representation and limited appearances. Chris asked that any other comments be sent to him within 7 days. There will be an e-vote later in June or July. State bar voted to support this proposed court rule amendment.
- 2) ADM File No. 2017-06; MCR 7.300 et seq. These are continued discussion on amendments that are administrative in nature. The court rules committee recommended that council oppose the language providing for a "vexatious litigator". Chris made a motion to oppose the language as approved by the committee. Liz Bransdorfer seconded the motion. Motion passed.

C. Legislation

Kent Weichmann discussed the status of HB 4691. There was lengthy discussion and council believed it would be up for a vote the following Tuesday. Kent made a motion that the council oppose HB 4691 and include reasons as indicated by the legislative committee as well as any other reasons after additional review. Dan Bates seconded the motion. Motion passed.

After discussion, it was decided that the motion would be broken into subparts of the statute. A motion to approve amendment to MCL 750.136c passed 13 in favor, 0 opposed and 3 abstentions. This did not include MCL 750.136c(3)(a).

Motion to approve amendment to MCL 750.136c(3)(b) was made by Jim Chryssikos and seconded by Shelley Kester. After much discussion, Randy Velzen called the question, Sahera Housey seconded which resulted in 15 voted in favor, 0 opposed and 2 abstained.

Randy Velzen then made a motion to approve amendment to MCL 750.136c(3)(a), Jim Chryssikos seconded. The motion failed 8 approved, 9 opposed.
