 - 2. HB 4679 foreign law; "anti-shari'ah law", sees this as political football; not necessary directly for family law; received no position (20 approved).
 - 3. HB 4883 amend paternity act confinement to abate if dad has the children; mechanics of the bill are a problem, relationship; received: oppose the bill as currently worded, need alternative language; motion move to accept recommendation (20 approved).
 - 4. SB 547 parenting plan bill; this bill is a mixed bag; problematic language; quirky language; rec oppose bill; move to accept recommendation, vote: (20 approved).
 - 5. SB 557, 558, 559, 560 paternity act; this bill is complicated, lots of different status; addresses a genuine problem; recommendation: amend to one year savings clause be added; motion to recommend passage with one (20 approved).
 - 6. Group: non bills we will weigh in:
 - A. Sex offender bill need case by case, etc.; recommendation: judicial discretion is necessary in these cases.
 - 7. Schumacher committee recommends that the committee express to the senator that would be more than harmful
 - 8. Minor/majority issue: 17 year old demanding child support from parents be abandoned; there is a case already; unnecessary in light of Nelson decision; unanimous approval
