Mr. Martina's presentation included a report on his discussions over the Summer with Rep. Runestad and Attorney David Helm, in efforts to work on a proposal that both accomplishes some of Rep. Runestad's goals while also making sure any modifications to existing law serve as an improvement over what is in place now. There are significant challenges to accomplishing both of these goals. Diligent efforts are being put forth to draft a proposal that improves current law. Council has not formally voted on a counterproposal to HB 4691, and continues to oppose HB 4691.
