## Legislative issues:

- Opposed SB 652 (to change the make-up of the Court of Claims)
- Opposed SB 743 (to make bar membership voluntary)
- Supported proposed changes to probate appeal rules
- Proposed change to court rule re: video deposition transcripts
- Opposed change to e-filing rules that would impose 5 PM deadline

#### Recommendations for next Council:

The Council enjoyed an excellent relationship this year with court staff and personnel. Inviting the chief clerks from the COA and MSC to each meeting, and asking them to extend the invite to their bench and clerk's office, resulted in judges and court and clerk staff attending many meetings, to everyone's benefit.

#### Other Information:

The committee reviewed requests for amicus brief participation; provided donations to the Just the Beginning; Pre-Law Summer Institute; and Wolverine Bar Judical Externship Program; and the group performed 2 community service activities (soup kitchen and Ronald McDonald house).

The Council is currently reviewing proposed changes to the Michigan Court Rules governing practice in both the Court of Appeals and Supreme Court, they aren't formal yet but we have been asked to consult in the original brainstorming and drafting sessions. We are also consulting on changes to the e-filing system and the intiation of e-filing in the Supreme Court.
