1. Executive Orders; SCAO Actions

A list of Executive Orders affecting real estate matters follows. Several orders update or extend prior orders. Note that the temporary notary order, Executive Order 74, expires June 30, 2020 though one might expect that it could be extended yet again. Executives Orders related to commencement of court actions have been adjusted in some regards.

The Supreme Court has issued guidance to address an anticipation of a flood of eviction action and set priorities for hearings. SCOA 2020-17.

- 2. **Monthly Call**. The Committee did not have a monthly call in June.
- 3. **Marketable Title Act**. A bill extending the effective date of Pubic Act 572 of 2018 which amended the Marketable Title Act, has been introduced and as of June 2, 2020 is in the Ways and Means Committee. 4. Bills of Interest; New Acts.

The Legislature has not been active in passing bills for obvious reasons. One can expect budget issues will occupy both houses throughout the summer. Passage of bills will likely be at best sporadic. The following new legislation of interest has been introduced since the last report in May, 2020. Again a number of bills attempt to address issues associated with the CoVid-19 crisis. Of particular note is Public Act 88 of 2020 (HB 5766) which extends property tax appeal deadlines to late August.

Note should also be taken of two bills affecting powers of attorney, HB 5768 and 5769, which require acknowledge by the agent of its powers and duties.

HB 5793 and HB 5794 are proposed revisions to the Michigan Consumer Protection Act which appear to have a possible impact on certain licensed occupations such as builders and real estate brokers, but their exact purposes are hard to parse exactly.

The bill about Confederate flags, SB 906, has particular resonance for the times. Might Council wish to take a position in light of current events?

- 5. **Pending Legislation; Positions**. Bills on which we recently took action remain in committee and have not advanced.
 - a. HB 4123 and 4699. These bills essentially authorize a lien against all real estate throughout the state owned by an owner of even a single blighted property subject to blight citations.
 - b. HB 4676 and HB 4677. The bills essentially attempt to bar certain noisome restrictions related to race, religion and sexual orientation, etc. which is a laudable goal.
 - c. HB 4509 about members of single member LLC's representing an LCC in eviction action has moved to Judiciary and Public Safety Committee in the House.
- 6. **Prior Bills.** There was no activity on the following bills of interest:
 - a. **Emotional Support Animals**. SB609 and SB 610, about emotional support animals and residential landlord tenant issues seem to remain viable. They are however still in the Committee on Local Government.
 - b. **Tree Liability; HB 4915**. This bill seems to have lost momentum. We continue to monitor it. Comments received can be summarized as the proposal is an unnecessary dramatic change from settled law and is fraught with unintended consequences.
 - c. **Soil Erosion Bill. SB 0714** Dealing with temporary erosion control structures being authorized without permit during high water levels seems to have legs and has moved to the Committee of Natural Resources and Outdoor Recreation.
 - d. **Assignment of Rents Statutes**. Likewise the bills related to a new assignment of rents statute, HB 5086 and HB 5092 remain in the Judiciary Committee.

GENERAL LEGISLATIVE BACKGROUND

With the state beginning to open back up, the Legislature has begun meeting more regularly, but there is no guarantee the budget is done by the new July 1st deadline (after last year's budget fight that lasted until September 30th). Committees have begun meeting more as well, but the Legislature is following CDC guidelines, which means things are moving even slower than normal for them.

LEGISLATION SIGNED INTO LAW SINCE LAST REPORT

LEGISLATION OF INTEREST

SENATE BILLS

Tax Tribunal – SB 26 (Sen. McBroom, R – Vulcan) Creates requirement as to what it is to be considered in certain tax tribunal determinations in assessment disputes. *Referred to Senate Committee on Finance.*

Assessment Disputes – SB 39 (Sen. McBroom, R – Vulcan) Sets requirements under the Tax Tribunal Act for what is to be considered in certain tribunal determinations in assessment disputes. *Referred to the Senate Committee on Finance.*

Winder Energy Systems – SB 46 (Sen. VanderWall, R – Ludington) Clarifies in General Property Tax Act the assessed valuation of wind energy systems. *Referred to the Senate Committee on Finance and received a hearing on January 22, 2020.*

Alternative Energy – SB 48 (Sen. Barrett, R – Charlotte) Modifies property tax exemption for alternative energy systems on personal property. *Passed the Senate, has been referred to House Ways & Means Committee.*

Historic Preservation Tax Credit – SB 54 (Sen. Schmidt, R – Traverse City) Restores the State Historic Preservation Tax Credit program. *Hearing in Senate Finance on December* 11th.

Property Tax – SB 59 (Sen. Chang, D – Detroit) Provides for the freezing of taxable value for primary residences of certain senior citizens. *Referred to the Senate Committee on Finance*.

Eviction – SB 112 (Sen. Lucido, R – Shelby Twp.) Modifies the process for a property owner to evict a person. *Passed the House & Senate, awaiting action by the Governor.* Legislative Committee recommendation is that this is not legislation on which RPLS should take a position.

First-Time Home Buyer – SB 120 (Sen. MacGregor, R – Rockford) Creates a Michigan first-time home buyer savings program. *Received a hearing in Senate Committee on Finance.*

Home Buyer Deduction – SB 121 (Sen. Horn, R – Frankenmuth) Provides for a tax deduction for contributions made to the first-time home buyer program. *Received a hearing in Senate Committee on Finance.*

*Property Taxes – SB 360 (Sen. Stamas, R – Midland) Provides an exemption for certain eligible data center property from property taxes. *On Third Reading in the Senate.*

Process Service – SB 420 (Sen. Lucido, R – Shelby Twp.) Modifies procedures in process serving. *Passed Seante, hearing in House Judiciary (5/19).*

Income Tax Credit – SB 421 (Sen. Moss, D – Southfield) Establishes credit for purchase of certain housing and for certain home modifications. *Referred to Senate Finance*.

Income Tax Credit – SB 422 (Sen. Moss, D – Southfield) Authorizes certification of income tax credit by the Michigan State Housing Development Authority. *Referred to*

Senate Finance.

Land Use – SB 431 (Sen. Hollier, D – Detroit) Modify conditions under zoning ordinance may prohibit mining. *Committee hearing in Senate Transportation and Infrastructure* (2/19/2020).

Limited Liability Companies – SB 440 (Sen. Irwin, D – Ann Arbor) Modifies annual statement fees under the Michigan limited liability company act. *PA 70 of 2019*.

Licensing Fees – SB 441 (Sen. Santana, D – Detroit) Modifies occupational code fees under the State License Fee Act. *PA 71 of 2019*.

Stormwater Permits – SB 447 (Sen. Hertel, D – East Lansing) Extends the sunset for surface water and stormwater discharge permit fees under the Natural Resources and Environmental Protection Act. *PA 84 of 2019.*

Commercial Redevelopment – SB 494 (Sen. Stamas, R – Midland) Extends the sunset from December 31, 2020 to December 31, 2025 for the Commercial Redevelopment Act. *Passed Senate, received hearing in House Commerce and Tourism* (1/16/2020).

Emotional Support Animals – SB 608 (Sen. MacGregor, R – Rockford) Provides for early lease termination due to misrepresentation of emotional support animals. *Received hearing in Senate Local Government (10/31).*

Emotional Support Animals – SB 609 (Sen. Zorn, R – Ida) Clarifies the definition of service animal to exclude emotional support animals. *Received hearing in Senate Local Government (10/31).*

Emotional Support Animals – SB 610 Creates regulations on the prescription of and requests for reasonable accommodation for emotional support animals. *Received hearing in Senate Local Government (10/31).*

Property Transfer – SB 658 Allows for transfer of certain state-owned property in Mecosta County. *Senate Appropriations*.

Property Tax – SB 676 (Sen. Lucido, R – Shelby Twp.) Modifies the General Property Tax Act as it relates to distribution of revenue from sale of foreclosure. *Senate Finance*.

Housing Discrimination – SB 687 (Sen. Irwin, D – Ann Arbor) Provides for a prohibition for landlords to discriminate against renters based on source of income. *Senate Local Government*.

Ownership – SB 692 (Sen. Zorn, R – Ida) Changes the Housing Law of Michigan related to housing inspections as it relates to change of ownership to exclude certain transfers. *Passed Senate, referred to House Local Government and Municipal Finance.*

Erosion Control – SB 714 (Sen. Victory, R – Hudsonville) Authorizes the temporary construction of erosion control structures without a permit during times of high water levels. *Passed Senate, awaits committee referral in House.*

Evictions – SB 720 (Sen. Lucido, R – Shelby Twp.) Modifies the Revised Judicature Act of 1961 regarding procedures to recover possession of premises because of assault, battery, or unlawful drugs to require a conviction. *Referred to Senate Judiciary and Public Safety*.

Property – SB 721 (Sen. Lucido, R – Shelby Twp.) Modifies the Personal Property Trust Perpetuities Act regarding determining the period of vesting for future interests. *Senate Judiciary and Public Safety.*

Tax Increment Financing – SB 723 (Sen. Outman, R – Six Lakes) Provides for the approval by local units of government for certain plan extensions for tax increment financing. *Senate Economic and Small Business Development*.

Tax Foreclosure – SB 725 (Sen. Runestad, R – White Lake) Modifies certain notices of delinquent tax foreclosure proceedings. *Passed the Senate*.

Tax Foreclosure – SB 726 (Sen. Johnson, R., R – Holly) Modifies certain procedures involving delinquent tax foreclosure proceedings. *Passed the Senate*.

Housing Exemption – SB 787 (Sen. Ananich, D – Flint) Modifies the housing exemption for elderly or disabled families. *Senate Finance*.

Speedy Trial – SB 791 (Sen. Lucido, R – Shelby Twp.) Provides for certain requirements for a speedy trial. *Senate Judiciary and Public Safety.*

Transcript Fees – SB 793 (Sen. Irwin, D – Ann Arbor) Increases transcript fees for courts. *Senate Judiciary and Public Safety.*

Evictions – SB 912 (Sen. Geiss, D – Taylor) Provides relief from evictions during certain states of emergency. *Senate Finance*.

Lease Termination – SB 913 (Sen. Irwin, D – Ann Arbor) Allows tenants to terminate leases during certain states of emergency. *Senate Finance*.

Foreclsoures/Evictions – SB 914 (Sen. Alexander, D – Detroit) Provides for moratorium on foreclosures and evictions during certain states of emergency. *Senate Finance*.

Foreclosures – SB 915 (Sen. Hollier, D – Detroit) Provides for moratorium on foreclosures by MSHDA during certain states of emergency. *Senate Finance*.

Foreclosures – SB 916 (Sen. Chang, D – Detroit) Provides for moratorium on foreclosures for those complying with public health directives during certain states of emergency. *Senate Finance*.

Tax Tribunal Appeals – SB 917 (Sen. MacGregor, R – Rockford) Modifies deadlines for Tax Tribunal appeals. *Senate Finance*.

Summer Property Taxes – SB 943 (Sen. MacGregor, R – Rockford) Extends payment deadline for summer 2020 property taxes. *Senate Finance*.

House Bills

The House has a two committee process. Only four committees (Ways & Means, Appropriations, Government Operations, and Judiciary) may report bills directly to the floor. While all others have to report bills to Ways & Means before the bill can be reported to the floor.

Short-Term Rentals – HB 4046 (Rep. Sheppard, R - Temperance) Limits regulation of vacation and short-term rentals. *Received a hearing in the House Committee on Local Government and Municipal Finance.*

Property Assessments – HB 4047 (Rep. Brixie, D - Okemos) Modifies certain tribunal determinations in assessment disputes as to the valuation of property. Also known as "dark stores." *Referred to the House Committee on Local Government and Municipal Finance.*

Nonprofit Corporations – HB 4048 (Rep. Inman, R - Williamsburg) Authorizes merger or conversion into nonprofit corporations for summer resort and park associations. *Had advanced to Third Reading on the House Floor, but has been re-referred back to the House Committee on Commerce & Tourism.*

Association Mergers – HB 4049 (Rep. Inman, R – Williamsburg) Authorizes merger or conversion into nonprofit corporations for summer resort and park associations. *Had advanced to Third Reading on the House Floor, but has been re-referred back to the House Committee on Commerce & Tourism.*

Property Tax – HB 4050 (Rep. Inman, R - Williamsburg) Allows transfer of ownership from a general or limited partnership to certain individuals to be exempt from uncapping taxes after transfer. *Passed House Local Government and Municipal Finance, has been referred to House Ways and Means.*

Alternative Energy – HB 4068 (Rep. Kahle, R – Madison Twp.) Modifies alternative energy property tax exemption. *Received a hearing in House Tax Policy.*

Historic Preservation Tax Credit – HB 4100 (Rep. Frederick, R – Owosso) Restores state historic preservation tax credit program. *Referred to the House Committee on Tax Policy*.

Income Tax – HB 4110 (Rep. Garza, D – Taylor) Increases property tax credit for certain qualified veterans. *Referred to the House Committee on Tax Policy*.

Blight Violations – HB 4123 (Rep. Whitsett, D - Detroit) Modifies attachment of property lien for failure to pay fine for blight violation to include all land, buildings, or structures owned by defendant in the state. *Referred to the House Committee on Local Government and Municipal Finance.*

Property Tax Credit – HB 4157 (Rep. Iden, R – Oshtemo Twp.) Removes eligibility based on homestead taxable value cap. *Referred to the House Committee on Tax Policy*.

Veteran Property Tax Exemption – HB 4158 (Rep. Iden, R – Oshtemo Twp.) Modifies affidavit filing requirements for disabled veteran exemptions. *Referred to the House Committee on Local Government and Municipal Finance.*

Brownfield Redevelopment – HB 4159 (Rep. Iden, R – Oshtemo Twp.) Provides oversight of brownfield redevelopment authorities. *Senate Economic & Small Business Development*.

Property Management – HB 4160 (Rep. Hoitenga, R – Manton) Modifies certain licensure requirements for employees or agents of a real estate broker hired to perform duties relating to property management. *Referred to the House Committee on Regulatory Reform.*

Lead-Free Pipes – HB 4175 (Rep. Cherry, D – Flint) Revises definition of lead-free pipes and pipe fittings to match federal definition. *Referred to House Committee on Regulatory Reform.*

Property Tax Exemptions – HB 4176 (Rep. Yaroch, R – Richmond) Hold local taxing units harmless for disabled veteran exemption. *Referred to House Committee on Military, Veteran, and Homeland Security.*

Public Safety Property – HB 4185 (Rep. Farrington, R – Utica) Modifies provision related to malicious destruction of fire or police department property to include real property. *Passed the House, referred to Senate Judiciary and Public Safety Committee.*

Property Tax – HB 4214 (Rep. Leutheuser, R – Zeeland) Modifies small business personal property tax payments. *Referred to the House Tax Policy Committee.*

Property Tax – HB 4215 (Rep. Farrington, R – Utica) Increases small taxpayer exemption threshold for eligible personal property. *Referred to House Committee on Tax Policy*.

Foreclosure Sales – HB 4219 (Rep. Howell, R – North Branch) Modifies distribution of revenue from sale of foreclosure. *Referred to the House Committee on Local Government and Municipal Finance.*

Notaries – HB 4292 (Rep. Webber, R – Rochester Hills) Revises eligibility requirements for notary public appointment and requires record keeping. *Referred to House Judiciary Committee.*

Property Tax – HB 4387 (Rep. Chirkun, D – Roseville) Modifies criteria to qualify for property tax exemptions for disabled veterans. *Referred to House Committee on Local Government and Municipal Finance.*

Moral Character – HB 4488 (Rep. Iden, R – Oshtemo Twp.) Restricts use of criminal record to determine eligibility for occupational licensing. *House Ways & Means*.

Moral Character – HB 4489 (Rep. Bellino, R – Monroe) Clarifies good moral character qualifications for admission to state bar. *House Ways & Means.*

Home Inspections – HB 4494 (Rep. Schroeder, R – Independence Twp.) Establishes licensing fees for home inspection services and provides for deposit of proceeds into occupational fund. *Referred to House Regulatory Reform Committee.*

Home Inspections – HB 4506 (Rep. Schroeder, R – Independence Twp.) Provides for licensure and regulation of home inspection services and requires certain disclosures and contract provisions. *Referred to House Regulatory Reform Committee*.

Evictions – **HB 4509** (Rep. VanSingel, R – Grant) Allows limited liability company members and others with personal knowledge to represent them in certain situations. *Passed the House, referred to Senate Judiciary and received hearing on (1/30/2020).*

Bankruptcy – HB 4521 (Rep. Frederick, R – Owosso) Modifies value of home equity exempted from bankruptcy. *Referred to House Judiciary Committee.*

Short-Term Rentals – HB 4554 (Rep. Lilly, R – Park Twp.) Creates short-term rental promotion act that provides for registry of short-term rentals. *Referred to the House Commerce and Tourism Committee*.

Short-Term Rentals – HB 4555 (Rep. Ellison, D – Royal Oak) Revises stadium or convention facilities act to include certain short-term rentals. *Referred to the House Commerce and Tourism Committee*.

Short-Term Rentals – HB 4556 (Rep. Marino, R – Harrison Twp.) Modifies state convention facility development act to include certain short-term rentals. *Referred to the House Commerce and Tourism Committee.*

Short-Term Rentals – HB 4557 (Rep. Brixie, D – Okemos) Modifies excise tax on business of providing accommodations to include certain short-term rentals. *Referred to the House Commerce and Tourism Committee.*

Short-Term Rentals – HB 4558 (Rep. Paquette, R – Niles) Revises regional tourism marketing act to include certain short-term rentals. *Referred to the House Commerce and Tourism Committee*.

Short-Term Rentals – HB 4559 (Rep. Sabo, D – Muskegon) Revises community convention or tourism marketing act to include certain short-term rentals. *Referred to the House Commerce and Tourism Committee*.

Short-Term Rentals – HB 4560 (Rep. Webber, R – Rochester Hills) Revises convention and tourism marketing act to include certain short term rentals. *Referred to the House Commerce and Tourism Committee.*

Short-Term Rentals – HB 4561 (Rep. O'Malley, R – Lake Ann) Revises regional convention and tourism promotion act to include certain short-term rentals. *Referred to the House Commerce and Tourism Committee*.

Short-Term Rentals – HB 4562 (Rep. Calley, R – Portland) Revises convention and tourism promotion act to include certain short-term rentals. *Referred to the House Commerce and Tourism Committee.*

Short-Term Rentals – HB 4563 (Rep. Tate, D – Detroit) Permits short-term rentals. *Referred to the House Commerce and Tourism Committee.*

*Restrictive Deeds – HB 4676 (Rep. Anthony, D – Lansing) Prohibits restrictive covenants in deeds and other instruments. *Referred to the House Committee on Judiciary*.

*Restrictive Deeds – HB 4677 (Rep. Brixie, D – Okemos) Exempts actions under the prohibited restrictive covenants act from any statute of limitations. *Referred to House Committee on Judiciary*.

Liens – HB 4695 (Rep. Brann, R – Wyoming) Requires licensed contractor to provide certain documents when recording claim of lien. *Referred to the House Committee on Regulatory Reform.*

*Property Lien – HB 4699 (Rep. Whitsett, D – Detroit) Allows for property lien attachment to all land, buildings, or structures, owned by defendant in this state. Referred to the House Local Government and Municipal Finance Committee.

Veterans Homes – HB 4742 (Rep. Howell, R – North Branch) Requires testing of water at Michigan veterans' facilities established under 1885 PA 152.

Veterans Homes – HB 4743 (Rep. Tate, D – Detroit) Requires testing of water for lead at veterans' facilities established under the Michigan veterans' facility authority act.

HB 4742 and HB 4743 were referred to House Ways and Means.

Lead in Drinking Water – HB 4744 (Rep. Love, D – Detroit) Provides for program for testing and removing lead in drinking water used by vulnerable population centers. *House Natural Resources and Outdoor Recreation.*

PFAS Action Response – HB 4746 (Rep. Griffin, R – Mattawan) Codifies Michigan PFAS action response team. *Referred to House Ways and Means.*

Water Quality – HB 4749 (Rep. Afendoulis, R – Grand Rapids Twp.) Requires source water testing for public water supplier proposing to hook up a new water source. *Referred to House Ways and Means.*

Water Quality – HB 4750 (Rep. Kennedy, D – Davison) Requires disclosure of lead service line by water suppliers to customers and by landlords to tenants. *Referred to House Ways and Means*.

Bed Bugs-Landlord Tenant- HB 4777 (Rep. Iden, R Kalamazoo) Prohibit a landlord from renting a unit infested with bedbugs; prohibit tenants from moving infested items into a unit or attempting to apply pest control treatments themselves; and require tenants to grant reasonable access to professional pest management personnel and comply with the control protocols established by the landlord. Tenants who cause an infestation would be responsible for treatment costs, and landlords who follow the rules would have their liability limited for the infestation and items damaged by treatment

Property Tax – HB 4828 (Rep. Byrd, D – Detroit) Revises poverty exemption. *Referred to House Local Government & Municipal Finance.*

Property Tax – HB 4851 (Rep. Hoitenga, R – Manton) Modifies property tax exemption for disabled veterans. *Passed House, referred to Senate Finance.*

Support Animals – HB 4910 (Rep. Hall, R – Emmett Twp.) Creates regulations for the prescription of and request for reasonable accommodation for emotional support animals. *Senate Regulatory Reform*.

Support Animals – HB 4911 (Rep. Cambensy, D – Marquette) Provides for early lease termination due to misrepresentation of emotional support animals. *Senate Regulatory Reform*.

Tree Liability – HB 4915 (Rep. Berman, R – Commerce) A bill to establish liability and provide remedies for damage resulting from falling trees or tree branches. *Referred to House Local Government and Municipal Finance, received hearing (10/16).*

Estate Tax – HB 4922 (Rep. Johnson, C., D – Detroit) Repeals Michigan estate tax act. Passed House Tax Policy, referred to House Ways and Means, hearing on March 12^{th} .

Property Tax – HB 4927 (Rep. Vaupel, R – Fowlerville) Modifies local community stabilization share revenue distribution. *Passed House, referred to Senate Finance.*

Property Tax – HB 4928 (Rep. Webber, R – Rochester Hills) Modifies distribution of local community stabilization share revenue. *Passed House, referred to Senate Finance.*

Property Tax – HB 4929 (Rep. Yancey, D – Harper Woods) Modifies certain calculations related to tax increment financing plans. *Passed House, referred to Senate Finance.*

Property Tax – HB 4930 (Rep. Whitsett, D – Detroit) Modifies reporting deadlines and procedures for certain distribution calculations. *Passed House, referred to Senate Finance*.

Assignment of Rents – HB 5091 (Rep. Iden, R – Oshtemo Twp.) Clarifies that action regarding assignment of rents does not constitute an action under the "one-action" rule. *Referred to House Judiciary*.

Liens – HB 5092 (Rep. Iden, R – Oshtemo Twp.) Makes subordinate to security interest in rents priority over other liens. *Referred to House Judiciary.*

Property Taxes – HB 5124 (Rep. Byrd, D – Detroit) Modifies provisions for reducing redemption amounts. *Passed the House and Senate, awaits action by the Governor.*

Drains – HB 5126 (Rep. Johnson, S., R – Shelbyville) Revises requirements to petition to add or remove lands and notice of receipt of bids and review of apportionments. *Hearing in House Local Government (6/3/2020).*

Delinquent Taxes – HB 5170 (Rep. Byrd, D – Detroit) Makes delinquent property tax installment payment plans and tax foreclosure avoidance agreements available for certain commercial real property returned for delinquent taxes. *Referred to House Local Government*.

Construction Documents – HB 5197 (Rep. Maddock, R – Milford) Authorizes electronic or digital retention of construction documents and allows for disposal of original construction documents. *Passed the House and referred to Senate Local Government*.

Construction Documents – HB 5198 (Rep. Maddock, R – Milford) Clarifies disposal of certain construction documents. *Passed the House and referred to Senate Local Government.*

Housing Discrimination – HB 5224 (Rep. Byrd, D – Detroit) Prohibits housing discrimination relating to military status. *Referred to House Government Operations*.

Property Tax – HB 5238 (Rep. Shannon, D – Sterling Heights) Modifies exemption for disabled veterans. *Referred to House Local Government*.

Condos - HB 5260 (Rep. Paquette, R – Niles) Exempts certain instruments relating to condominiums from the marketable record title act. *Referred to House Local Government and received hearing (2/5/2020).*

Housing Discrimination – HB 5287 (Rep. Wittenberg, D – Huntington Woods) Prohibits housing discrimination based on source of income. *House Local Government and Municipal Finance*.

Housing Discrimination – HB 5288 (Rep. Rabhi, D – Ann Arbor) Prohibits housing discrimination based on source of income. *House Local Government and Municipal Finance*.

County Property – HB 5314 (Rep. Markkanen, R – Hancock) Modifies provision related to contracts or agreements for the purchase of real or personal property for public use. *House Ways and Means.*

Property Tax – HB 5335 (Rep. Robinson, D – Detroit) Provides for reduced redemption and stipulated payment agreements. *House Local Government and Municipal Finance*.

Civil Procedure – HB 5336 (Rep. Iden, R – Oshtemo Twp.) Modifies uniform commercial real estate receivership act. *Referred to Senate Judiciary with an H-3 Sub.*

Lead Levels – HB 5359 (Rep. Hood, D – Grand Rapids) Modifies definition of elevated blood level. *House Health Policy*.

Blood Lead Levels – HB 5360 (Rep. Anthony, D – Lansing) Modifies reporting requirements for blood lead levels for minors. *House Health Policy*.

Lead-Based Paint – HB 5361 (Rep. Love, D – Detroit) Requires lead-based paint inspections before the sale or transfer of certain real property. *House Regulatory Reform.*

Lead-Based Paint – HB 5362 (Rep. Gay-Dagnogo, D – Detroit) Requires inspection and correction of violations under housing law to include lead-based paint inspection and abatement. *House Regulatory Reform*.

Vaccines – HB 5363 (Rep. Yancey, D – Harper Woods) Provides for lead screening of minors as part of immunization records. *House Health Policy*.

Lead Abatement – HB 5364 (Rep. Garza, D – Taylor) Requires certain parties to submit documentation supporting affirmative defense to failure to perform lead abatement. *House Health Policy.*

Lead Poisoning – HB 5365 (Rep. Cherry, D – Flint) Requires screening minors for lead poisoning at intervals required by the Department of Health and Human Services by rule and require documentation of screening in certificate of immunization. *House Health Policy.*

Paint Taxes – HB 5366 (Rep. Hood, D – Grand Rapids) Provides for tax levy per gallon of paint and earmark revenue for a lead remediation program. *House Tax Policy*.

Lead Paint Remediation Credit – HB 5367 (Rep. Hood, D – Grand Rapids) Provides for tax incentive to be certified to perform lead-based paint activities. *House Tax Policy*.

Construction Contracts – HB 5375 (Rep. Elder, D – Bay City) Regulates payment practices under construction contracts and subcontracts. *House Commerce and Tourism*.

Pretrial Risk Assessment – HB 5646 (Rep. Lightner, R – Springport) Creates requirements for the use of a pretrial risk assessment tool. *House Judiciary*.

Property Tax – HB 5480 (Rep. Farrington, R – Utica) Modifies filing of combined document for certain personal property tax exemptions. *House Local Government and Municipal Finance*.

Appraisers – HB 5481 (Rep. Farrington, R – Utica) Modifies appraisal management company requirements. *Senate Regulatory Reform*.

Soil and Erosion – HB 5485 (Rep. O'Malley, R – Lake Ann) Creates a task force for flooding and erosion issues. *House Natural Resources and Outdoor Recreation*.

Neighborhood Enterprise Zones – HB 5775 (Rep. LaFave, R – Iron Mountain) Modifies eligibility requirements for neighborhood enterprise zones. *Hearing in House Commerce* (6/10).

Land Banks – HB 5822 (Rep. LaGrand, D – Grand Rapids) Modifies definition of qualified city for economic development authorities. *House Local Government*.

Real Estate Referrals – HB 5823 (Rep. Johnson, S., R – Shelbyville) Modifies compensation for referrals. *House Regulatory Reform*.
