**Recommendations for next Council:** The next Council should continuing working with the State Bar of Michigan on improving the Section's website and the online offerings available to the Section's members. It should also continue pursuing outreach and educational programs for newer members of the State Bar and expand participation in the Section by real estate lawyers located outside of southeast Michigan.
