#### V. TREASURER'S REPORT:

Mills advised the Financial Statement reports status of funds remain stable at higher levels than previous years due to lack of conference costs. No substantial change in position from last meeting.

#### VI. AMICUS COMMITTEE

Mithani reported no new requests for amicus support. Mithani and Mills will reconcile list of support and expenses. Discussion regarding amicus update in January edition of *Briefly*. Bluhm thanked Council for joining in *City of Troy* case last meeting. Williams noted strong behind the scenes work of the Amicus Committee.

### VII. GLS Briefly Editor

Mills and Fox presented report detailing click and open rate of Briefly over the past few years, and plans for future articles. Mills requested author and article ideas. Council extended appreciation to Mills and Fox for the work.

### VIII. Social Media Committee

Council conferred regarding whether to coordinate membership and social media committee activities. Seth Koches, as a member of the committee, noted difficulties imposed by COVID. Mithani asked whether this committee's work helped increase readership/click rate of *Briefly*. Joppich acknowledged crossover between the membership and social media committees, but the separate work and purpose is enough to remain separate. Council acknowledged Section website as an area for improvement and possible task of the social media committee. Bluhm and others support separate committees to increase opportunity for participation from membership.
