Amicus Committee: Attorney Chris Patterson joined to discuss the case Wineries of the Old Mission Peninsula ("WOMP") v Peninsula Township and request for amicus participation in the case on appeal. Patterson gave an overview of the case and identified several appellate issues. Eric Williams asked Patterson to identify the top 2 or 3 issues that GLS might address as amici. He identified (I) Preemption (Michigan Liquor Control Code); (2) Dormant Commerce Clause; and (3) Vagueness (due process claim). McGee did not participate in the discussion or the vote. Member McGee disclosed that he and Member Mithani represented the Plaintiffs in the litigation below and therefore, would need to abstain from voting. McGee did not participate in the discussion.

Motion by Williams/Joppich to authorize GLS to participate in the WOMP v Peninsula *Township* case as amicus and to author an amicus brief, at a total cost not to exceed \$15,000.00. Motion adopted by 2/3 vote in compliance with the requirements of Article VII, Section 4 of the State Bar of Michigan Bylaws (13-0 with 3 abstentions):

10. <u>Council Comments</u>

- a. Lori Bluhm advised the Council about the recent Court of Appeals decision in Michigan Ass'n of Home Builders v. City of Troy, involving the City's assessment of building department fees and the implications of the Headlee Amendment. The Michigan Supreme Court denied the City's application for leave to appeal October 29, 2025.
- b. Mike Watza brought to the Council's attention several right-of-way issues being followed by PROTEC including:
 - i. \$150 million in Cable/Video Franchise fees at risk due to 3rd year of streaming industry seeking a legislative exemption;
 - ii. FCC started two proceedings September 30 seeking expansion of the Small Cell preemption doctrine to previously unrelated preemption of local government control over wireline Telecom access to our ROW and, Wireless telecom access to public lands and, our regulatory control over wireless facilities on private lands.
 - iii. Northville ROW Court battle regarding the ability of City Council to govern its ROW. An Amicus is likely to be sought. PROTEC may respond. GLS should consider filing an amicus brief as well.
- c. Anthony Chubb brough to the Council's attention the case Let's Open Northville v. City of Northville, where the City appealed the Circuit Court's decision and requested expedited review by the Court of Appeals. Chubb noted the City is also looking at proposing legislative amendments to resolve this matter for it and all other communities and sought thoughts from the Council on proposed legislative amendments.

d. Chris Patterson thanked the Council for the opportunity to present on WOMP v Peninsula Township.
