ANNUAL MEETING MINUTES

1. Approval of June 9, 2022 meeting minutes (All)
 - a. After review and discussion, Sinkwitts moved to approve the minutes; Schebor seconded. Motion approved.
2. Secretary/Treasurer's Report (Schebor)
 - a. Discussion on current state of finances.
 - b. Approval for Annual Program Speaker Stipend – After review and discussion, Sinkwitts moved to approve a motion to provide our speaker with a stipend in the amount of \$1,000. Helminski seconded. Motion approved.
3. Administrator's Report (Parks)
 - a. Been working on the Summer Program, and then focused on the Annual Program. Going to be working on the Joint Fall Conference next. Summer Program. Also still working on making sure that everyone is receiving Constant Contact.
4. Chair's Report (Sadler)
 - a. Recognition of and thank-you to departing Council members

5. Annual ELS Council Elections for 2022-23 (All)

 - c. A call for nominations from the floor yielded no additional candidates. A motion was made by Helminski, seconded by Kissling, to adopt and elect the slate of candidates as presented above. The motion passed unanimously.
