Legislative issues: The Council discussed the recent legislation, SB 743 but has not taken a position on the issue due to further clarification needed. As the Task Force Report has recently been issued, the Section will review those findings and determine whether what action, if any, is needed.

Recommendations for next Council: More seminars to educate membership on hot topics; consider a summer one-day retreat to prepare a joint agenda for the year; establish an agenda early; prepare for more educational and social events jointly with other 'like' sections; a stronger presence in legal education programs for schools, including but not limited to Law Day, Constitution Day, as well as mentoring options. The Section should concentrate new membership attention on law students and recent bar takers.
