# DEBTOR/CREDITOR RIGHTS COMMITTEE REPORT PREPARED FOR THE MARCH 10, 2011 COUNCIL MEETING

## 1. Next Scheduled Meeting of the Committee

Next scheduled meetings of the Committee:

A conference call on the Michigan Exemption Initiative is scheduled on March 11, 2011 at 3:00 p.m.

An educational meeting on the limited liability company law for creditors' rights practitioners is scheduled for May 11, 2011.

The Committee conference call on February 25, 2011, prompted by the case law alert on *In re Schafer*, had 16 participants, including attorneys in Grand Rapids, Traverse City and Bay City, as well as the more typical participation from southeastern Michigan

# 4. Accomplishments Toward Committee Objectives

The Committee has moved forward towards accomplishing several objectives:

- (a) A meeting was held on January 11, 2011, attended by nine members despite a major snowstorm.
- (b) The Committee has designated contact persons:

- (c) For purposes of successor leadership for a co-chair, if necessary (although no change is contemplated at present), Thomas Morris has agreed to serve and the Committee approved his selection;
- (d) The Committee has arranged an educational event at its May 11, 2011 meeting, at which Dan Minkus will speak on limited liability company law for creditors' rights practitioners. This topic was suggested by our members.
- (e) A procedure for case law alerts was established.

(f) The Committee discussed recent rule changes and case law at its January 2011 meeting.

### 5. Meetings and Programs

As discussed above, the Committee met on January 11, 2011 and will meet again on May 11, 2011 for a meeting and educational program on limited liability company law. Dan Minkus will speak.

The Committee held a conference call on its Michigan Exemption Initiative on February 25, 2011 and has scheduled another call for March 11, 2011.

We expect to arrange an additional educational event later this year, based on topics suggested by the members.
