ANNUAL MEETING MINUTES

September 20, 2012

The Annual Meeting of the Business Law Section of the State Bar of Michigan was held at the Sheraton Detroit Novi in Novi, Michigan on September 20, 2012, pursuant to notice duly given.

- 1. <u>Call to Order and Determination of Quorum</u>. Section Chairperson, Edwin Lukas, called the meeting to order at approximately 5:11 p.m. and determined with the other officers present that a quorum existed.
- 2. <u>Approval of Minutes of September 13, 2011 Annual Meeting.</u> Mr. Lukas called for a motion to approve the Minutes of the Annual Meeting held on September 13, 2011. Pursuant to motion duly made and seconded, the Minutes were approved.
