Publication of *Michigan Business Law Journal*

Volume XXV, Issue 1 of the *Journal* was published in May 2005. Volume XXV, issue 2 is in the process of being copyedited. We are currently soliciting articles for the November 30, 2005 issue, including article on the focus topic of commercial litigation.
