The Summer issue of the *Journal* was mailed the first week of September. Articles for the next issue (November 2013 – Financial Institutions) are being received and reviewed. As discussed earlier in the meeting, the ICLE contract has been renewed for one year.

The inside front cover and inside back cover have been revised slightly to clarify that articles should be of a business law nature. Also, we now require authors to sign a copyright license that permits the Section to grant permission to third parties to reprint *Journal* articles without the need to seek consent from the article author. We reserve the right to edit all submissions for length, clarity, organization, style and conformance with these Guidelines; substantive changes are subject to author approval. We reserve the right to refuse to publish any article.

Copyright License

Authors must sign the Business Law Section copyright license before an article will be published. All rights to published articles will be held jointly between the author and the Business Law Section.

Citations

The ICLE publications department will citecheck and edit the citations in your article for consistency. However, by following a few of our style rules, you can make the editing and production processes go more smoothly.

- Please do not use periods within citations.

 - MCL 339.2503 (not M.C.L. 339.2503)
 - 1982 PA 338 (not 1982 P.A. 338)
- Please do not use section symbols.
 - 15 USC 18 (not 15 U.S.C. §18)
 - MCL 722.51 (not M.C.L. §722.51)
- □ Italicize case names; please do not underline.
- □ Use the following citation form for books:

- Brown, Preventive Law 25 (1950).
- ☐ Use the following citation form for articles:
 - Reese, Legislative Jurisdiction, 78 Colum L Rev 1587 (1978).
- Please use endnotes for citations rather than parenthetical or footnote citations.

Basic Style Guidelines

 - · carve-out; cyber court
 - e-business; e-mail

 - numbers: spell out numbers one through nine; use figures for numbers 10+
 - online
 - Web conferencing; Web site
