TREASURER'S REPORT March 3, 2005 Submitted by Mark R. High

- 1. <u>2004-2005 Fiscal Condition</u>. The Section is in good financial condition. The income statement issued by the State Bar for the period ending January 31, 2005, is attached as <u>Exhibit 1</u>. For the period through January 31, 2005, the Section had total income consisting of \$111,453 and expenses of just \$19,208.19, resulting in net income to the Section of \$92,241.81. We ended the period with a fund balance of \$201,857.20.
- 2. <u>2004-2005 Budget</u>. Attached as <u>Exhibit 2</u> shows the Committee and Directorship budget requests which I have received. <u>Exhibit 3</u> shows the final Section Budget, and a budgeted loss of \$7,950. <u>Exhibit 3</u> also shows year-to-date revenue and expenses.
- 3. <u>Membership</u>. Section membership has dropped from 3,661 members in the 2003-04 period to approximately 3,425 this year, a reduction of about 6.5%. I have not tracked this for prior years, so I cannot say how much of this is due to the dues increase and how much may just be historical. According to 2004 numbers, the Business Law Section is the third largest after Probate (5,000+) and Real Estate (about 3,700).
