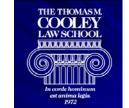

### Income/Expenses for October 2012 through August 2013

Attached is a one-page spreadsheet showing (in small, but (hopefully) readable type) our current chart of accounts with our fiscal year 2013 budget, the results of the Section's operations for the eleven months ended August 31, 2013, and the results of operations for each of the eleven months individually. I have also included a second, one-page spreadsheet showing just the budget and the eleven months ended August 31, 2013 results (in a larger type).

I have also included two items prepared by the State Bar of Michigan for the Business Law Section: (a) the income statement for the eleven months ended August 31, 2013; and (b) the Detailed Trail Balance from the General Ledger documenting paid Business Law Section expenses from October 1, 2013 through August 31, 2013. These are the two reports the Chair and the Treasurer receive from the State Bar after the end of each month. ### Revenues

Even though we still have the month of September to complete the current fiscal year, we historically have not had any revenues in September. We may have some Business Boot Camp revenues this month (as we did in 2010), but those should be thought of as part of the next fiscal year for planning purposes. Which is to say, from a revenue stand-point, Fiscal Year 2013 is done.

Having said that, the picture is a good one. The dues increase gave the Section additional revenues without causing an exodus of members. We were just \$305 below our budgeted revenues in our dues categories, and we budgeted based upon no loss of membership.

Overall, we should finish the year about \$5,000 above budget on revenues. The BLI Sponsorships came within \$300 of budget. The area where we had the large overage in revenues was in our Seminar category. Seminar income for FY2013 is almost \$5,500 above budget and pretty much accounts for our over-budget revenues.

### **Expenses**

Most budgeted expenses are close to or within their budgeted amounts. Seminar expenses are a bit higher than budgeted, but the additional Seminar income more than accounts for such overages. We normally budget the Seminars as an overall loss, but for FY2013, we did several

seminars and currently have a modest surplus in this category overall (about \$1,100 revenues over expenses).

As we only have the month of September expenses remaining for FY2013, it might be most useful to look at past Septembers. Expenses booked in September during the last three fiscal years were: \$22,215.52 (Sep 2012); \$22,359.90 (Sep 2011); and \$38,523.90 (Sep 2010). The main reasons for the large September 2010 expenses were BLI costs paid in September, which is the case this year as well.

Our most common expenses in September (other than the occasional year that includes BLI) are Administration, Annual Meeting, and Business Law Journal. If we simply assume that we will come close to budget on each of those items through additional payments in September, and we add in the recent BLI bill of \$18,151.35, we can expect at about \$39,000 in expenses for September.

As we currently have booked \$93,453.77 in expenses for the year, we should be on target to have about \$132,500 in total expenses. While these are just estimates and additional expenses may materialize, this is VERY good news from a financial stewardship standpoint. We should have modest increase (about \$2,500) to our fund balance for FY2013 rather than the budgeted \$36,000 decrease in reserves.

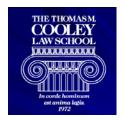
Variations from the budget appear in a few areas, the most notable being:

We had budgeted a net decrease in reserves of \$36,000 for FY2013. This chart basically shows how we avoided that loss. Committee and Section Development were both considerably under budget. These cost savings certainly contributed to the positive fiscal result as opposed to the large negative budget, although these may be areas where we want to increase, rather than decrease, activities.

As a general rule, organizations such as the BLS should have 50% to 150% of annual expenses in reserve. Our anticipated fund balance of about \$127,000 at the end of this year puts us in the mid-part of this range. While I certainly think that we need to have a balanced budget for the normal operations of the BLS, we may have the fund balance to permit us to make some targeted investments, so long as such endeavors do not become recurring expenses every year.

As we discontinued out-sourcing our social media updates, our Section Face book account also came in significantly under budget. Further, travel done on behalf of the Section was in connection with, and billed to, specific activities. This means that travel expenses were paid, but that there were no general travel expenses booked to the Travel account. Most other expenses were properly anticipated and



accounted for in other budget categories, so we do not have any large miscellaneous expenses to date.

### **Chart of Accounts**

Attached to this report is the new Chart of Accounts that was recently approved by the State Bar of Michigan. It looks significantly like the proposed chart of accounts distributed previously, although there are some differences based upon the needs of the State Bar.

The main difference from our current Chart of Accounts to the new Chart of Accounts is that each of the Committees now has its own revenue and expense category. This should make the reports much more "committee friendly" during the year. Other categories have been renamed to better reflect how we are actually using them, although there are not many substantive changes. While this new Chart of Accounts does not represent a major overhaul or any big change in how we conduct our operations, I hope that these minor changes add up to better, more usable, financial reporting.

When preparing financial information for future budgets, please do not "net" the overall expenses against the revenue. We now have the proper revenue accounts to track monies paid in as part of the financial reporting. Each budget request should include a "revenue" number (which may be zero in certain instances) as well as an expense estimate. This should help the Officers and Council to better understand the financial steps and ramifications of what we are doing.
