You may note that for this 12 month period, Section total revenues were \$118,111.68, total expenses were \$126,348.37, leading to a reduction in fund balance of \$8,236.69. This reduction is substantially less than the budgeted reduction of \$37,271. However, please note that the total revenue was \$8,262.32 less than the prior year.
