Publications Committee Report (Becky Glitman)	A) The committee is working to publish the publications from the 2018-19 year. The following publications are being worked on:
	1) Opioid prescribing in Michigan Impact on Clinical Care (new rules) the committee is working on the final read through this weekend. The committee is hoping to get this published shortly.  2) Payment Contracting Provider Appeals (McLaren/McLaren Health Plan) – still waiting to receive a paper. No other authors submitted a proposal for this topic so the committee is trying to work with the authors.
	Three different "call for authors" were sent to the HCLS membership in mid-December and a reminder was emailed earlier this week. The committee has received quite a few responses. Mercedes and Becky discussed if at least one submission was received on each topic. Becky thought that at least one submission was received on each topic. The goal is to have the papers published in late spring or early summer.
	The topics are as follows: 1) Behavioral Health, 2) Scope of Practice Delegation NPS, Nurse Anesthetists and lower level licensure, and 3) Healthcare Facility Closure Rules in Michigan.
