Review and Approval of Minutes of January 3, 2013 Council Meeting (Steve Bender)	Minutes were unanimously approved without changes.

A motion was made to approve the resolution, provided the phrase "Potentially eligible law schools:" is added before the list of law schools beginning on page 1 of the resolution. The motion was seconded and unanimously approved. The resolution provides that the amount of the Academic Achievement award for 12-13 will be \$1,500 per eligible law school. Health Care Law Section-State Bar of Michigan Law School Academic Achievement Award Program

The Health Care Law Section (the "Section") of the State Bar of Michigan resolves to establish and fund the Law School Academic Achievement Award Program (the "Program") for students enrolled in healthcare law course study at eligible Michigan law schools.

PURPOSES OF THE PROGRAM

The purposes of the Program are:

- to recognize outstanding academic performance by law students in the field of healthcare law.
- to increase membership in the State Bar of Michigan and the Section by increasing law student awareness of the Section,
- to develop potential future leaders in the Section,
- to induce outstanding law students to practice law in Michigan and join the Section upon their admission to the State Bar of Michigan,
- to aid in deferring the cost of obtaining a legal education in Michigan through the award of a prize, and
- to increase awareness and perception of the Section with law students, the members of the State Bar of Michigan and the general public by setting an example of philanthropic leadership and support for outstanding academic achievement.

APPROPRIATION AND USE OF AWARD

To achieve these purposes, the Section shall appropriate an amount approved on an annual basis by the Section Council to eligible students at the law schools set forth below, provided the law school meets the eligibility requirements set forth by the Section. In the inaugural fiscal year of 2012 – 2013, that amount shall be \$1,500.00 per eligible law school. Potentially eligible law schools are:

- University of Detroit Mercy School of Law,
- University of Michigan Law School,
- Michigan State University College of Law,

- Thomas M. Cooley Law School, and
- Wayne State University Law School.

Each eligible school will grant the award to a student enrolled at the school who exhibits high achievement in healthcare law courses or other upper level health-law-related courses approved by the Section and as determined by the dean of the school. The award will be given in the name of the "Health Care Law Section-State Bar of Michigan" and presented as a "Health Care Law Section Academic Achievement Award" or in the case of University of Detroit – Mercy School of Law, "The Thomas J. Trenta Health Care Law Section Academic Achievement Award", or other equivalent award as applicable to each school.

ELIGIBILITY REQUIREMENTS FOR RECEIPT OF AWARD

The Section sets forth the following requirements by which the recipient law school must abide to be eligible for receipt of the award:

- The student winner of the award must be <u>someone who has made a commitment</u> to remain in Michigan following graduation and taking of the Michigan bar exam,
- The student winner must attend a ceremony designated by the Section for the purpose of being presented with the award, which the Section will endeavor to make concurrent with the Section's annual meeting so as to further expose the students to the practice of healthcare law,
- The law school must publicize the existence of the award, such as through advertising the award on the law school's website, in the law school's financial aid/development office or through any other means ordinarily used by the law school to publicize other competitive awards or scholarships.
- Each law school must be able to accommodate and implement this award under the conditions set forth by the Section. Failure to do so will result in a law school's ineligibility for this Award until the next fiscal year in which such law school notifies the Section of its eligibility.

FUTURE AWARDS

The Section is interested in providing the award for the next three years at which time it will evaluate the Program to determine whether it is achieving the outlined purposes. At that time, the Section may also consider expanding the Program to include an endowment feature. Additionally, the Section reserves the right to modify or discontinue the Program with or without notice at any time; provided, that once the award is approved by the Section for any fiscal year, the Section will not modify or discontinue the Program until the Section's next fiscal year.
