
STIPULATION SETTING PRIORITY


1. The Defendant Treasury was named as a Defendant in this matter.
2. Treasury recognizes that the interest claimed by the Plaintiff in the property which is the subject of this cause, is senior and prior to the interests claimed by Treasury.
3. In the event that this action results in sale of the subject property, the Plaintiff's attorney will send notice of sale to the Department of Attorney General,

Revenue & Tax Division pursuant to MCLA 440.9611. Any excess proceeds from said sale, over and above the amount necessary to satisfy the Plaintiff's claim, will be applied to the amounts due and owing any junior lien holders in accordance with the priority of their interest.

4. Accordingly, as part of the Stipulation Setting Priority, Plaintiff and Defendant Treasury agree that no costs or attorney fees will be awarded to either party.
