Ms. Smith called the meeting to order at 9:04 a.m.

MINUTES OF PRIOR COUNCIL MEETING

Ms. Smith presented the Council Meeting Minutes of February 16, 2018. Mr. Combs motioned to approve and Mr. Peruski seconded. The minutes were unanimously approved.

TREASURER'S REPORT

Mr. Combs presented an update on the budget for the 2017-2018 fiscal year attached as Attachment A. Mr. Combs noted that a number of income items were recognized and dues were slightly lower than budgeted. Additionally, a small unexpected expense for a state report was recognized and \$1,000 Townsend reservation expense was incurred.

COUNCIL ACTIVITIES

1. Strategic Planning - Ryan Peruski

Mr. Peruski was present and provided a report. October 25 is the date for the Fundamentals Program with two committed speakers.

Ms. Pugliesi suggested contacting the local bar organizations, the MWTA and others for the Fundamentals Program. Mr. Gregory suggested publishing in Oakland County's Laches.

2. Public Communications - Brian Gallagher

Mr. Gallagher was absent but provided a written report, attached.

3. Michigan Tax Lawyer - Mindi Johnson

Ms. Johnson presented on the status of the current schedule for the next issue of the Michigan Tax Lawyer. Ms. Johnson Indicated that the current Michigan Tax Lawyer is scheduled for next month with 4 substantive employee benefits articles.

2018 - Andrea Crumback/Jeff Kirkey:

Furthermore, he recommended a follow-up for the list-serve. Ms. Smith mentioned that one speaker may be needed and Ms. Smith has a tentative speaker for Federal Tax Reform.

Ms. Smith led a discussion on the checklist for administering the Tax Conference including marketing, law student recognition, attendance, CPE/CLE, and other matters.

Mr. Monaghan mentioned the law schools and 5 nominees to receive grants. Mr. Stanley discussed the grant program and requested confirmation of members for the grant committee. Mr. Combs confirmed that we need to vote on the grants.

Ms. 5mith and Mr. Kirkey discussed special consideration for law school attendees and governmental officials in an effort to encourage attendance.

George Gregory presented a liaison report on retention of court records by probate courts and proposals to destroy records, do-not-resuscitate orders for minors, tax foreclosure process, and changes to EPIC where a small estate would be \$100,000 and would increase amount you can transfer without probate. Mr. Gregory mentioned that consideration of S.B. 540 is still in process, to address issues with respect to the Redd case about the standard to remove a guardian. All MI courts are supposed to use e-filing. The Allard case and pre-nups in a divorce — a house bill would make sure it works in a divorce; however, the family law section is opposed.

Upcoming seminars include one on income tax planning (May 16) in Acme, MI. There is also an annual institute in Acme that is open; the annual conference is also coming up for the Probate Section.

13. State Bar of Michigan Liaison Report - Shenique Moss

Ms. Moss was not present and did provide a report.

14. Program Facilitator Report - Mary Owiesny

Ms. Owiesny was present, but did not have anything to report.
