  - o Farkas shared that there might be an upcoming amendment to the proposed instruction. Gobbo suggested that the Council take no action.
- Midwinter Conference (Farkas, Antovski, and Gilbert)
  - o Farkas reported that the Midwinter Conference will be via Zoom on February 13, and that it will focus on the topics of diversity, implicit bias, and racial justice.
  - Spiliopoulous reported that the committee made contact with several possible speakers, but no one has committed to speaking at the conference yet.
- Diversity Committee (Nyamfukudza, Nelson, Brown, Greene, Zeineh)
  - o The Chair reported that the Diversity Committee met and discussed further ideas and details for the scholarships. The committee discussed the possibility of two \$4,000 scholarships for law student interns from diverse backgrounds; one would go to a law student in a prosecutor's office and one would go to a law student in a public defender's office.
  - o Lloyd shared that it costs a prosecutor's office \$7,000 per term to fund a law student intern.
  - o Zeineh shared that he believed the term "diversity" should be further defined because there are many interpretations.
  - o The Chair sought general approval from the Council to continue perusing and discussing this idea. The Council expressed general approval to continue discussing the scholarships.
