I. Call to Order –

- Steve Gobbo called the meeting to order at 6:45pm
- Attendance Reminder to sign in
- Other. Discussion re next meeting and location at Lansing Country Club.
- Council introductions

II. Secretary's Report/Meeting Meetings

- Discussion re unexcused and excused absences
- Clarke moved to approve minutes as amended, seconded by Brady, carried.

III. Treasurer's Report

- SBM still in process of completed year-end reports, will forward when received.
- Gobbo mentions the need to approve council meeting expenditures. Clarke moved to approve expenditures for the meetings through the end of the calendar year. Seconded by Taratuta. Mike Marutiak made friendly amendment to authorize through the end of the bar year. Seconded by Brown.
- Motion carried unanimously of all voting members 18-0.

- Frankenmuth/Policy Conf./Other. Sherrie Guess now on committee. Committee had phone conference this afternoon. Marutiak making presentation for C. Marr since he was unable to make the meeting. Dates of June 10-11, 2016 (Friday/Sat)

coincide with Bavarian Festival, pending availability confirmation from hotel. All day Friday, 1/2 day Saturday. Proposal: Marr and Spiliopoulos heard from people in the field and would like theme to be something along the lines of evaluating truthfulness – suggested Susan Constantine who is a national expert discussing body language, voice tone, etc. Specialty is training attorneys. Full day presentation so we could have her present all day Friday or wrap around Friday afternoon/ Saturday with other speakers. Jury selection topic possible. We normally come in under budget – want to keep registration fee low to draw people, proposing to leave to committee. Fee for speaker is \$7,000. - Forfeiture bills (HBs 4499, 4500, and 4503 4507) package signed by Governor. 1 bill not part of package, HB 4629 re eliminating requirement to post cash bond. Blanchard moved to support, Guess seconded. Discussion. Motion 14-1 (members missing from room for vote).
- HB 4766 Teen court no action.
- HB 4969 Physician jury duty. Caprathe moved to oppose, seconded by Brown. Carried 17-0. (Members not in room)
- SB $453 3^{rd}$ class district courts (where cities/townships fund the court). No action.
- HB 4138 Presumptive parole. Passed House. Only applies to those considered low-risk, demonstrated high probability of parole, Prisons and Corrections voted to support. Tied up in senate in committee. Blanchard moved to support, seconded by Marutiak. Discussion. Timmons motioned to table, seconded by Smith. Carried 8-6 (members out of room for vote).
- HBs 4973-4975. Child abuse registry bills. Blanchard moved to oppose, seconded by Malkin. Discussion. Carried 15-0-2.
- HBs 4947-4966. Tabled.
- HB 4713- Mens rea. Tabled.
- HB 4536, SB 291. Wrongful imprisonment compensation. Reported out of committee. Discussion re movement. Tabled.
- HB 4321. Search and seizure re resident consent. Blanchard moved to support, seconded by Marutiak. Discussion. Carried 13-2 (members left).
- HBs 4419 and 4420. Felony firearm. On house floor. Tabled.
